A strip of land being 20 feet in width running parallel with and immediately adjacent to the southern boundary of both Parcel I and Parcel II hereinafter described:

PARCEL I:

The East 50 feet of even width of the following described tract, to-wit:

Part of the Joseph B. Rogers Donation Land Claim in Township 3 South, Range 2 West of the Willamette Meridian, Yamhill County, Oregon, described as follows:

Beginning at a point South 00°03' East 121.27 and North 89°35' East 145 feet from the Northeast corner of fractional Block 50 of EDWARDS ADDITION to the Town (now City) of Newberg, Yamhill County, Oregon, and being also on the North line of that tract conveyed from Keiling to Newton by deed recorded in Book 120, Page 511 of Yamhill County Deed records, at a point North 89°35' East 145 feet from the Northwest corner of said tract; thence North 00°03' West 147.4 feet; thence North 89°35' East 70 feet; thence South 00°03' West 147.4 feet; thence North 89°35' West 70 feet to the point of beginning.

Rogers Donation Land Claim in Township 3 South, Range 2 West of the Willamette Meridian, Yamhill County, Oregon, described as follows: Beginning at a point South 00°03' East 121.27 feet and North 89°35' East 215 feet from the Northeast corner of fractional Block 50 of EDWARDS ADDITION to the Town of Newberg, Yamhill County, Oregon, and being also on the North line of that tract conveyed from Keiling to Newton by deed recorded in Book 120, Page 511 of Yamhill County Deed records, at a point North 89°35' East 215 feet from the Northwest corner of said tract; thence North 00°03' West 147.4 feet; thence North 89°35' East 45.02 feet to the Westerly margin of Wynooski Street; thence South 27°0' East along said street line, 164.82 feet; thence South 89°35' West 119.72 feet to the point of beginning.
