UTILITY EASEMENT

The City of Newberg (hereinafter referred to as the "City") has requested a utility easement in order to access and maintain the newly developed fire hydrant and water supply line on property owned by the First Presbyterian Church (hereinafter referred to as the "Church") at 501 Mission Drive, Newberg Oregon.

This nonexclusive easement effective on the <u>Stellar</u> day of October 2001 is given by the Church to the City and includes a 15-foot area over and above the water line. The legal description is provided in the attached "Exhibit A". The easement is given for the access and maintenance of the above mentioned water line and fire hydrant.

The City shall have unobstructed ingress and egress of the easement and will hold the Church harmless from any and all claims arising from the City's use of the property. The Church shall have full use and control of the property excepting any structures within said easement area.

The easement shall become void at such time said water line and hydrant is removed or abandoned by the City.

Exhibit "A" Legal Description 15' Waterline Easement

BEING a 15.00 foot wide waterline easement located in the Daniel Deskins Donation Land Claim No. 54 in the Southeast One-Quarter of Section 18, Township 3 South, Range 2 West, Willamette Meridian, City of Newberg, Yamhill County, Oregon, and being 7.50 feet on each side of the following described centerline:

Beginning at a point on the north right-of-way line of Mission Drive (60 foot wide right-of-way) being N 90°00'00" E 18.00 feet from the southeast corner of Lot 3, Block 2 "Kirkwood Addition" as recorded in the Yamhill County Plat Records;

Thence N 00°12'00" E, parallel with the east line of said Lot 3, 135.00 feet to the terminus of the herein described centerline.
