Purpose of item

The purpose of this agenda item is to inform the commission about streamlining efforts for state government. Michael Jordan, Oregon's Chief Operating Officer and DAS director, will present this item.

Background In February 2011, Governor Kitzhaber named Michael Jordan the director

of the Oregon Department of Administrative Services and the state's first Chief Operating Officer. Director Jordan served as the chief operations officer with Metro, the regional government for the Portland metropolitan

area, from 2003 to 2011.

Since his appointment, Director Jordan has led DAS, and the state, in efforts to improve government services and state agencies through a number of innovative strategies. Director Pedersen serves on the Enterprise Leadership Team, a group of 25 agency directors and executives that has met regularly since summer 2011 to assess enterprise-style funding and program implementation strategies Oregon can use to

improve its services.

EQC The commission will have the opportunity to discuss the Enterprise **involvement** Leadership Teams and Oregon's 10-Year Plan with Director Jordan.
