Dear Glenn Zirkle,

The Oregon Department of Environmental Quality (DEQ) is conducting underground storage tank (UST) inspections throughout Oregon. The purpose of this letter is to inform you that your facility(s), among others, has been selected for inspection. A thorough inspection of your facility will be conducted to determine compliance with state and federal UST requirements. **The date you receive this letter is the date that the inspection starts.** If you have work done after that date, you will need to have the previous set of records available for evaluation in addition to the most recent records.

The inspections for these facilities have been scheduled for Wednesday April 10, 2024. The first inspection will start at approximately 8:30 am located at 3520 SW Patton Rd. The remaining three inspections will directly follow.

Please read this entire notice and contact the DEQ inspector if you have questions about the upcoming inspection.

The inspections will require uninterrupted participation and attendance by you or a knowledgeable assistant. For the inspections you need to provide access to tank sumps, under dispenser areas, cathodic protection rectifiers, and leak monitoring equipment. DEQ will not touch the equipment or enter the facility; **if you are unable to assist with equipment access, please have your UST Service Provider there**. This inspection may also include review of Stage I Vapor Recovery.

The DEQ requests the following documentation be submitted electronically prior to the inspection to lauren.dimock@deq.oregon.gov. If these records cannot be submitted prior to the inspection, please have them available for review at the facility.

- Line and leak detector testing results for the past three years,
- Monthly tank leak detection records for the past 12 months,
- Class A, B, and C training documentation,
- Financial responsibility mechanism,

- Annual tank gauge certification,
- Spill prevention testing records,
- Monthly walkthroughs for the past 12 months,
- Overfill Prevention Equipment testing,
- Cathodic protection testing (if applicable).

Upon request, the DEQ inspector may allow up to five (5) days after the inspection to accept missing documents prior to making a final compliance determination. Any records submitted after an approved five (5) day extension will not be included for compliance determination and the inspection will be considered closed.

As stated previously, DEQ will not touch any equipment and if you are unable to assist with equipment access, please have your UST Service Provider there to remove manway or sump lids. DEQ will need to observe what equipment is in the tank top sumps and under the dispensers. If ball floats are the primary overfill protection device, these will need to be verified during the inspection, please be able to locate and remove the ball floats.

If violations are found at the time of the inspection without prior notification, DEQ is required to initiate enforcement action. For UST violations, enforcement usually begins with a field citation option, which is much like paying a traffic ticket and making corrections. Some enforcement situations, including repeat violations and significant compliance deficiencies, will go through a longer and more formal process through the Office of Compliance and Enforcement and can potentially lead to larger penalties.

RE: Warning Letter

Dear Glenn Zirkle:

The Oregon Department of Environmental Quality (DEQ) conducted an Underground Storage Tank compliance inspection at the facility located at 4027 SE Cesar Chavez Blvd, Portland, Oregon on April 10, 2024. The purpose of this letter is to inform you of the result of the inspection. Based on the findings, DEQ has determined that the Underground Storage Tank facility operations were **not in compliance** with the rules.

Based upon the inspection of your facility, DEQ has concluded that WSCO Petroleum Corporation is responsible for the following violation of Oregon environmental law:

VIOLATIONS:

(1) Failure to test spill prevention equipment at least once every 3 years. (Class I. OAR 340-150-310(8)(b)). This site has a Healy Mini Jet system installed in the regular tank sump. Due to manufacturer specifications, a mechanical line leak detector (MLLD) cannot be installed upstream of this system, meaning that the line between the submersible turbine pump and the MLLD is unprotected. DEQ has previously determined that this site can operate with this setup if interstitial monitoring is continuously conducted in this sump. Due to this requirement, the sump must also be tightness tested at least once every three years.

CORRECTIVE ACTION:

(1) Submit the results of sump tightness testing to DEQ by 6/30/2024, or use alternative method to meet DEQ rules in this sump.

Class I violations are considered to be the most serious violations; Class III violations are considered to be the least serious.

This notice is a warning letter. DEQ does not intend to take formal enforcement action at this time. However, should you repeat any of these violations, the matter may be referred to the DEQ's Office of Compliance and Enforcement for formal enforcement action, including assessment of civil penalties and/or a Department order. Civil penalties can be assessed for each day of violation.

If you believe any of the facts in this Warning Letter are in error, you may provide information to me at the office at the address shown at the top of this letter. DEQ will consider new information you submit and take appropriate action.

Thanks Mike. I have completed the inspection determinations for three of the stations, see attached. There are two warning letters with corrective actions for sump testing needed where there are healy mini jet systems (you can instead install electronic line leak detectors to meet the rules). There is a field citation for 202 for the two cracked spill buckets with a corrective action of repairing/replacing those. Please pay the field citation by 5/25/24. I set all corrective action deadlines to 6/30/24, please let the UST DO know if you need additional time to complete those.

Once you have the 2023 testing for 239 please send it my way and I will close that one as well. Note that I am out of the office starting tomorrow and won't be back until May 28^{th} , so that is when I'll be able to complete that inspection.

Hi Mike,

Thanks for sending the 2024 walkthroughs. I've compiled a list of items needed and observations at each site below, please get them to me by next Friday 4/19/24. Once we have cleared up all the paperwork needed I will make the compliance decisions and send them to you.

I spoke with Mark about the sites with healy mini jet systems and DEQ has been requiring sump testing for sites in similar situations of needing to monitor a single sump, as well as monthly monitoring records which we talked about. Therefore these sites will require triennial sump testing in addition to the monthly interstitial monitoring. An alternative to sump testing are possible would be installing electronic line leak detectors instead.

Astro #308 (7536)

1. **Need:**

1. Spill bucket replacement testing paperwork

2. Observations:

- Regular sump not tested required for interstitial monitoring. This is a violation that will be issued as a warning letter without penalty due to the unusual circumstances of the situation.
- 2. Reminder that interstitial monitoring records need to be printed every 30 days for the regular sump

Astro #238 (6234)

3. Observations:

- Regular sump not tested required for interstitial monitoring. This is a violation that will be issued as a warning letter without penalty due to the unusual circumstances of the situation.
- 2. Reminder that interstitial monitoring records need to be printed every 30 days for the regular sump

Astro #202 (6069)

- 4. Observations:
 - 1. The regular and diesel spill buckets were both cracked and need to be repaired/replaced and then re-tested. This is a violation.

Astro #239 (6237)

- 5. **Need:**
 - 2023 testing paperwork looked like the testing date was 11/8/23 based on the alarm history
- 6. Observations:
 - 1. The line leak detector was not on the turbine head for the diesel tank. The leak detector will either need to be moved onto the turbine head or an electronic line leak detector needs to be installed. This is a violation.
 - 2. I am still looking into the turbine in the manifolded regular tank. I understand that it is not possible to install a leak detector on the turbine/line. The remaining thing I am looking into is whether or not a sensor in this sump is needed (it is definitely strongly recommended to avoid a potential release into the environment). I will follow up with you on this when I have more info.
