






5,200 USTs Across Oregon

Between 2020 and December 2024



- 109 facilities decommissioned
- 204 new facilities installed or rebuilt



DEQ Contractor Oversight



- Not everything goes as planned
- Potential release to environment
- Ongoing cost




Unfortunately Releases Still Occur



- 2020 Springfield ruptured tank (8,000 gallons)
- 2021 Monmouth old equipment (15,000 gallons)
- 2022 Hillsboro lapses in routine maintenance (40,000 gallons)
- 2023 Baker ruptured line (1,000 gallons)
- 2024 McMinnville lapses in routine maintenance (3,000 gallons)





Condensed History of UST Program





Impact of 2020 Rule Implementation



- Pre 2020 inspection compliance rate 90%
- Post 2020 inspection compliance rate 40%
- Observed nationwide



Proposed Rulemaking

- Protect Oregon's groundwater
- Only licensed contractors may perform UST services
- Much lower compliance rate after 2018 rule update

Increase DEQ oversight of contractors



UST Rules

- OAR 340-150 implements federal requirements for equipment
- OAR 340-151 implements federal requirements for financial responsibility
- OAR 340-160 regulates UST Service Providers and Supervisors Oregon-specific, last updated in 2003




Division 160 Proposal

- Require notification of all UST work
- Require approval to proceed at critical junctures during construction
- Require submission of testing results
- Require proof of manufacturer certifications for testing and installation
