# EQC self-evaluation survey results and analysis for 2017 meeting year

Overall score: 96 percent

Target: 100 percent

Four commissioners completed a self-evaluation survey in June 2018. The results, seen below, were averaged for an overall score. Answers marked "Do not know" did not have a percentage result, and were not used to create the individual or averaged total scores.

The survey omitted three questions that were not applicable from the last version. These questions are at the end of this document and will be included in the 2019 evaluation of the 2018 meeting year.

#### Areas of strength

Generally, the commission displays strength and confidence across all topics and questions in the survey. Survey results indicate that the commission is generally satisfied with the information provided by DEQ, and the overall score trend is stable.

#### **Areas for improvement**

The commissioners scored questions one and eight the lowest, at 90 percent. These questions relate to the communications from DEQ to the commissioners and opportunities for commissioners to collaborate with other entities. DEQ will ask the commission for ways to improve these two sectors as part of the July 11-13, 2018, meeting discussion.
