ENGINEER: Current updates on the following projects:

Washington Ct. (6244 Washinton Ct.) This is a partition. All three houses purchased by Renaissance homes are staked.

Chick-fil-A: The construction work is underway. The request for the fire line meter is still pending. The irrigation meter was terminated.

Sunset Commons (16607 Boones Ferry– residential/commercial) The owner is in the process of value engineering.

5337 Bonita - New service and termination of existing service is still pending. The meter has been sized

for the new house. Nothing Scheduled yet. The plans have been received, and the builder was contacted last week.

5342 Bonita — The existing house was removed. A new home has been built. The developer is to build an onsite septic and new water service. Nothing Scheduled yet and no plans have been received.

6122 Carman Drive – (Pole Barn House) The meter has been sized, and nothing has been scheduled for the new service.

4375 Oakridge – New construction is well underway. The builder has been advised of LGWD requirements. The latest update is that there is possible new service in February.

16085 Inverurie Road (Woodlands Estates) – This is a 4-lot subdivision. The design firm was contacted and the LGWD extension plan is still under review.

Carman & Kruse Way crossing intersection – Records are limited at this crossing. The Engineer is working with Hiland and the Boring contractor to locate a 16-inch main line.
