This school zone would benefit from improved signage. Drivers are still exceeding the speed limit, keeping traffic flow above 20 mph during school hours. Earlier this year, a temporary LED sign significantly reduced speeds. Installing flashing lights during school hours or a permanent LED sign that alerts drivers when they are speeding could help address the issue. The school itself is not very obvious, which may contribute to the problem.
