

# **Primary Rulemaking Goal**

To instate a pro-active regulation that helps DEQ meet air quality standards, particularly for ozone and protects public health.


**Survey Question:** based on your knowledge, which regulatory model are you most supportive of?

#### **Toxics in Consumer Products**

Examples of compounds that can be toxic in consumer products:

- phthalates and other hormonal disruptors
- PFAS chemicals
- diethanolamines
- triclosan
- parabens
- formaldehyde





## **Toxics in Consumer Products**

• Some toxic compounds are prohibited in the CARB rules for certain product categories:

methylene chloride, perchloroethylene, trichloroethylene parachlorobenzotrifluoride, para-dichlorobenzene

 CARB and OTC rules also prohibit compounds that also have a global warming potential value of 150 or greater in many product categories



these 3 chemicals

## **Other Considerations Around Toxics**

- DEQ will favor a regulatory option that promotes safe reformulations
- There are several other regulations that will protect Oregon consumers from toxics, such as the Oregon Toxic-Free Cosmetics Act, which will take effect in 2027


## **CARB Alternative Control Plan**

- Voluntary alternative approach to comply with the VOC limits in the Consumer Products Regulation by allowing manufacturers to set up a plan for a group of products
- Allows averaging of expected VOC emissions across a group of products





#### **CARB Innovative Products Exemption**




- Manufacturer demonstrates that a product results in less VOC emissions than a "representative consumer product" typically because less product is needed
- Alternative pathway for compliance
- Provides flexibility to industry while still complying with regulation
