#### **Guest Presentations: Lebanon Chamber of Commerce**

Rebecca Grizzle, CEO of the Lebanon Chamber of Commerce reported on the Transient Occupancy Tax Funds that the Chamber receives. The City allocates \$42,000 to the Chamber for the operation of the Lebanon Visitor's Center and \$43,000 for grants. Past recipients of the grant include events such as the Strawberry Festival, car show, and antique fair. Grant applications are reviewed by a volunteer committee. The Transient Occupancy Tax can only be used for tourism.

The Motel Tax Fund is a total of \$397,533 of which \$42,000 is allocated for the operation of the Visitor's Center, \$43,000 for the grant program, \$30,000 for the Lebanon Downtown Association, \$50,000 for the Downtown Building Restoration Project and the remaining is to be used for city wide projects that meet the Transient Occupational Tax criteria of promoting tourism. It was noted the committee desires to continue quarterly payments to the LDA.

Finance Director Brandon Neish reported on the following funds: Internal Service Funds, Utility Funds and General Funds.

The Internal Service Funds includes building maintenance, mechanic, Informational Technology. Each operational fund contributes calculated by using operational expenses from the prior year. \$36,000 is allocated for Council stipends. There was a question regarding how an opt out program could impact the General Fund. The Council stated the stipends were not the reason they serve. The non-representative employees are not receiving a COLA in the FY 2024/2025 Budget and the Council stated they would propose to discontinue the stipend and exemplify leadership by example.

Motion made to discontinue the Council stipend for the FY 2024/2025 by Ullfers, Seconded by Steinhebel.

Information Technologies also supports the Lebanon Fire District with contracted services using a base rate. The Use of AARPA funds will help with the IT needs during the City Council Chamber relocation.

The Mechanic is part of the Building Maintenance Fund and distributed by number of vehicles per department. Building maintenance is determined by the number of hours per week spent in specific facilities. Funds are set aside yearly for potential issues with older buildings such as the possible need to replace an HVAC unit.

For the Utility Funds: The Water Utility Fund total expenditures are down 15.5%. The rate has increased 2%. Funds in the amount of 1.1M are allocated for expansion on membrane filters at the Water Treatment Plant for drawdown events.

Wastewater also has a decrease in total fund expenditures of 12.2%. Funds allocated for future projects are 12.1M.

Storm drain total expenses are down 32.9%, and rates for 2025 have increase 10% and that fee which was \$4.82 is now \$5.30.

In the General Fund revenue is up by 5.29% and property tax revenue is down 1%. The NW URD service payments have been accelerated and the debt will be paid and the URD closed out by the end of 2027. The overall General Fund shows a deficit balance by 2027. Some of the actions that have been taken to mitigate the deficit is the Management Team has suspended COLAs for the FY 2024/25 Budget, 2 park positions are not being filled adding \$200,000 in additional savings, and the savings from Council stipends will be \$38,000.

There were questions from the Committee about how the Fire District Levy would impact City Funds. Other general questions included the cost of the membrane filters and if there could be some recovery for those funds, how the School Resource Officer was funded, and what the franchise fees could be for PEAK.

Motion made to Add \$110,000 in fund 820 Equipment Reserve Fund and \$30,000 in fund 100 for the Council Dias by Ullfers, Seconded by Workman.
