The Chief was requested to ascertain if the Volunteer Department would accept lump sum payment each month based on number of active volunteers including Chief and other paid firemen, and the department to disburse the funds to the members however they wished . (Note: This would be equal to approximately \$142.00 per man per year.)

2. Question of send Tom McGinnis with Chief Paola and Chief Sanford of the Keiser Department to take delivery of new truck and drive it to Newberg, discussed. Chief Paola stated the volunteers suggested that McGinnis also go, that he would also recommend this, as the training received at the factory by McGinnis would offset the cost involved. Committee agreed to send McGinnis with Paola.

Excess revenues were from franchise fees 28%, Building and Plumbing fees 110%, Fines 46%, interest and miscellaneous 29%. Personal service costs in most departments were less than estimates.

The Committee to recommend to the Council that \$25,000 be used to offset 1977-78 tax levy and the balance be appropriated later for specific Capital Improvements and/or land acquisition.

The General Fund - fund balance as of June 30, 1977 will be much larger than original estimate. Due to the fact that revenues have exceeded estimates by 10% and estimated expenditures were 10% less the fund balance carry over may be reduced by \$95,000.

Excess revenues were from franchise fees 28%, Building and plumbing permit fees 110%, fines 46% interest and miscellaneous 29%.

Personal service costs in most departments were less than estimates.

This \$95,000 may be used to reduce the tax levy for 1977-78 or a supplemental budget may be approved later to appropriate this amount for expending.

By using this money as offset to tax levies it would also reduce in future years revenue from Federal and State Revenue Sharing and Anti Recession grants.

In lieu of tax relief it possibly could be used to reduce water charges for the year.

- 4. Police Department Promotions Based on Certification Discussed. Committee approved advancement of one step per year. Richard McCabe, Carl Miller, and Lois Parrett to be advanced one step at this time with the second step to be considered at July 1,1978. D. T. James, Ronald Niehus, Larry Hailey and John Struchen to be advanced onestep at this time. All approved by the Committee.
- 5. Overtime Costs in the Police Department. The excess overtime costs incurred in the Police Department from July to December, inclusive, were discussed by the Committee. This matter to be investigated further in hopes of reducing overtime by both the Finance and the Police Committees. Administrator advised that in all probability a Resolution will have to be passed by the Council in June to transfer from the Contingency Account funds to cover the excess overtime costs in this department.
- 6. Salary Negotiations for Year 1978-79. City Administrator suggested that negotiations be based on a 5% increase July 1, 1978 and consideration to a 2½% increase January 1, 1979, if CPI for urban wage earners and clerical workers, Portland area, exceeds 6.25% and less than 7.5%; or, if this same Index exceeds 7.5%, then the January 1st increase would be 5%. This to be based on the Index of October, 1977 to October, 1978. The Committee also approved an increase of 2½% additional for all female employees of the City.
- 7. The interest received on investments for December amounted to \$6,164 at an average rate of 6.6966. Mr. Hurford advised that the Hospital has now placed its excess funds in the State Investment Pool.

If CPI Exceeds 7.50% for October 1, 1977 to October 1, 1978, then the January 1, 1979 increase shall be 5%.

In addition to above all female employees will receive $2\frac{1}{2}\%$ effective July 1, 1978.

City Administrators salary to be adjusted on same basis; However this to be a net basis if a suitable benefit plan such as deferred compensation or annuity insurance can be obtained.

<u>Health insurance</u> - City will pay rate increase in addition to current amount paid by the City.

Dental - City will pay 50% of rate charged

<u>Miscellaneous</u> - A minimum of two hours pay for each time called into work other than regular scheduled work time. --- Now pay 1 hour.

Uniform allowance for Police Officers to be increased to \$25.00 per month for Officers and \$12.50 per month for matrons. Officers to purchase and maintain all equipment and uniforms.

The amount of Commission paid to Ray Buckley on the Bankers Life Retirement plan was discussed.

Mr. LaBonte, Mr. Chandler and City Administrator to meet with Mr. Buckley on this matter.

Administrator recommended that autos be made available to the Chief of Police and the City Engineer to drive home on conditions they be used for city business only. Approved.

1. Application of Newberg Garbage Service, Inc. to increase rates.

Mr. Swift, Attorney representing the Newberg Garbage Service presented the application with reasons for the rate increase showing inflation rate, increased personnel costs, equipment costs and operating costs.

The proposed rate increase averaged approximately 14 percent overall.

The Committee recommends approval of the rate schedule as proposed excepting the weekly - off curb to 50 feet street or alley be reduced from \$4.00 per month to \$3.90 per month. Also that the franchise be amended to provide that "solid waste" be expanded to include "recycleable materials." Exceptions to be made to protect civic activities of clubs, etc. from whom the franchise holder is purchasing recylceables. The income from recycling shall be included in calculating the annual franchise fees. In reducing the monthly can rate from the proposed rate the Committee considered the lesser mileage in transporting garbage from the City of Newberg than Dundee, and rural.

- 2. Request of the Chehalem Park and Recreation District for payment by the City of Newberg the amount of \$17,000 for development of the park in the College Park Subdivision. The Committee recommends that this request be denied for several reasons:
 - 1. The City does not have funds available for allocation from public lands funds as they have been committed for the next year or two.
 - The City has cooperated with the District in developing the park on North College Street with the large EDA grant.
 - 3. The City should not increase their tax levy to provide money for parks as the Chehalem Park and Recreation District is a public taxing entity also.
 - 4. Recommend that the District consider the suggestion of the City Administrator that the City provide grading in this park, sidewalks, storm drainage, water service and materials subject to approval of the Public Works Committee.

Meeting of the Finance Committee June 20, 1978

1. The City Administrator advised that the estimated ending fund balance as of June 30, 1978 should be revised upward from \$130,421 to \$191,421. This is due to the fact that for the current year (77-78) \$19,300 more revenue will be received than estimated and expenditures will be \$64,458 less than 77-78 budget estimate. Also the reserve for contingency has not been used.

Committee approved using the added fund balance of \$61,000 to reduce the current levy over 6 percent from \$172,453 to \$103,135. (Delinquent tax percent applied.)

2. Request of Lowe's Taxi Service to increase rates effective July 1, 1978 reviewed.

The committee requested that more detailed information for each employee be included for future salary step review requests.

3. Real property transfer tax discussed. Mr. Nulsen explained the tax to the committee and recommended a 50 cents for each \$500 selling price. However, stated that the County Assessor had not advised the estimated amount of property value transfers for the City.

Mayor Hall stated the County was considering a \$1.50 per thousand tax for County revenue.

Committee recommended that the County tax be endorsed providing 75% was paid to each cities in the County based on transfer in each city and if the county did not proceed at once dn this tax then recommendation be made to the City Council for a local property transfer tax.

- 3. Recommend an ordinance for a City "real property transfer tax" be submitted to the Council December 4th to become effective January 1, 1979. Tax at rate of 50 cents for each five hundred dollars of the value of consideration for transfer of real property.
- 4. Approved appropriation of \$6,000.00 for purchase of an electronic distance measuring instrument for the Engineering Department. \$3,000.00 from Contingencies account of water Fund and \$3,000.00 from Contingencies account of Sewer Fund.

FINANCE COMMITTEE MEETING December 15, 1978

- 1. Administrator advised that of the estimated \$36,000 expected to be received on Federal Anti Recession funds only \$1,733 has been received. Congress did not renew the bill this month. This will cause a shortage in General Fund Revenues. Recommend transfer of \$25,000 to the General Fund from Federal Revenue Funds that were appropriated for the Springbrook Street Improvement as this job will not be done until 1979-80 budget year. Approved.
- 2. Administrator advised that the cost of living adjustment due the employes at January 1, 1979 would be 5%. This is as per budget which stated that if the CPI index for Portland Urban Wage Earners and Clerical workers exceeded 7.50% for October that City increase would be 5%. At September 30th the index was 12.2%. Approved.
- 3. The Committee discussed tentative personal services for the 1979-80 budget. Suggest about same basis as this year with maximum to be held within the 7% Presidential guideline.
- 4. Briefly discussed public contracting and purchasing law as applied to insurance contracts.

The current "Agent of Record" may have been appointed without following the necessary procedures to comply with the public contracting and purchasing laws. It was recommended that a resolution be prepared to terminate the current "Agent of Record" and following the correct procedures obtain a new agent of record if this is deemed to be desirable.

The procedure for obtaining future insurance coverage and the distribution of commissions on the City's insurance policy including the employes retirement policy should be looked into.

Suggested that Yamhill County Insurance Agents Association may be a good "Agent of Record" with a local agent acting as their representative, however, this cannot be determined at this time.

Committee to recommend to the Council.

5. Administrator advised that all legal publication requirements on the sewer bond election had not been met. That the Mayor had called a special meeting of the Council for 5 P.M., December 15, 1978 to recommend cancelling the bond election scheduled for December 19th.

Committee to approve and to recommend new date of Tuesday, February 13, 1979 be set for sewer bond election.
