

POLICE COMMITTEE MEETING

The first subject discussed was presented by Dayton City Officials requesting the City of Newberg to consider contractual police service for their city. They further implied that the City of Lafayette would also be interested in similar arrangements.

After deliberation by the members present it was decided that it would not be feasible or practical for the City of Newberg to enter into such an agreement. Both Chief Hawkins and the Police Committee volunteered their services in any way necessary to assist in establishing a police department for Dayton should they desire. Chief Hawkins is to relay this decision to the City of Dayton.

The Police Committee authorized Chief Hawkins to implement a Sergeant selection process which will provide a promotion for a supervisory officer to enable 24 hour staff coverage.

The Police Department certification program and uniform allowance was briefly discussed and finalization and recommendation will be made in the near future.

Traffic control in new subdivisions was submitted by Chief Hawkins after consultation with City Engineer Leonard Smith and are attached herewith.

A discussion was held concerning Department policy regarding the issuance and wearing of body armour by Police Officers. Since numerous complaints have been received by Chief Hawkins from officers regarding the uncomfortable conditions created during the hot summer months, the Committee recommended delaying enforcement of our unwritten policy during daylight hours until a written policy is established.

Chief Hawkins reported our new police car has been received and will soon be in service and also that a new replacement officer, Robert Hughes is now working. Chief Hawkins further related that our grant application for L.E.A.A. funds to up grade our communications system will be reviewed and prioritized June 29, 1977. The results will be related as received.

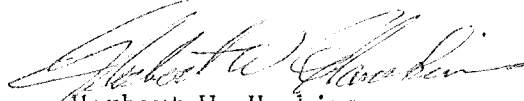
City Administrator Gilbert submitted a proposal for change in parking facilities around City Hall and the Newberg Human Resource Center. Changes recommended are as follows:

That one official parking space on First Street be changed to ten minute parking. The one half block from First Street to the alley on the west side of South Howard remain as police parking only. Also the first two parking spaces on the east side on South Howard just south of First Street

be for police parking only. The following three parking places south to the alley be proposed as public works parking. In addition the first five parking spaces west of Howard Street in the Human Resources lot be reserved for their needs and the balance of parking to be designated for City Employees.
