Round table discussion: Historic Preservation Ordinance

Staff identified that LCDC and SHPO requirements were currently not clearly delineated. He distributed a redraft of the Historic Preservation Ordinance which would meet at least minimum requirements of LCDC. The redrafted ordinance also deleted historic district identification.

Don Bauer, owner of a National Register historic site, identified some of the criteria for national registery designation.

The Commission then discussed the differences between draft 3 and draft 4 of the proposed ordinance.

<u>Motion</u>: Overton-Englebrecht to accept Draft 4 as a working outline. Motion carried unanimously.

<u>Motion</u>: Roberts-McIntosh to limit review of the ordinance to substantive issues and to allow Staff to do minor editing. Motion carried unanimously.

Motion: Kelso-Roberts to reinstate historic district language into draft 4.

Considerable discussion followed regarding the voluntary\compulsory inclusion in the creation of a historic district. Kathy Kelso and Arthur Roberts concurred that the intent of the motion was to incorporate historic district language into the context of the ordinance as a voluntary action.

Vote on Motion: Aye-Englebrecht, Fendall, Kelso, Kriz, Lyda, Overton, Roberts. Nay-McIntosh, Veatch. Motion carried (7-2).

<u>Motion</u>: Lyda-Englebrecht to revise Section 7-3 (e) to read "or shall be preserved if possible". Vote on Motion: Aye-Englebrecht, Fendall, Kriz, Lyda, McIntosh, Overton, Roberts. Nay-Kelso, Veatch. Motion carried (7-2).

<u>Motion</u>: Englebrecht-McIntosh to revise Section 16 to be included as item H under Section 4. Motion carried unanimously.

Discussion followed regarding what incentives could be put in place by the City to encourage the historic preservation of sites currently on the Inventory of Landmarks.

Incentives such as the presentation of an identification sign to each site, a citizen of year type award, an historic preservation party with awards, discounts from local lumberyards on materials, and creation of a computer inventory of building materials from the historic eras were all identified as possibilities that the Historic Preservation Commission might investigate.

It was identified that there are tax incentives available through the State for homes listed on the National Register.

<u>Motion</u>: Overton-Roberts to adjourn the hearing to a February 20, 1986 Planning Commission meeting to take place at 7:30 PM in the City Council Chambers. Motion carried.
