A RESOLUTION OF THE CITY OF ASTORIA ADOPTING THE 2025 ASTORIA HISTORIC PRESERVATION PLAN AS A GUIDING POLICY DOCUMENT

WHEREAS, the City of Astoria recognizes the importance of preserving the city's historic and cultural resources, which contribute to the community's identity, economic vitality, and quality of life; and

WHEREAS, the City of Astoria previously adopted a Historic Preservation Plan in 2008 to establish goals, priorities, and actions for the protection and promotion of the city's historic assets; and

WHEREAS, as a designated Heritage All-Star Community, the City of Astoria is committed to maintaining high standards for historic preservation planning and is eligible for grant funding from the Oregon State Historic Preservation Office ("SHPO"); and

WHEREAS, the City of Astoria received grant assistance from SHPO to prepare an updated 2025 Historic Preservation Plan, which reflects completed action items, community input, current preservation needs, and recent planning efforts, including the Historic Disaster Resiliency Plan; and

WHEREAS, the draft 2025 Historic Preservation Plan was reviewed by stakeholders, presented at a public work session of the Historic Landmarks Commission ("HLC") on April 15, 2025, and finalized following the HLC's recommendation on May 20, 2025; and

WHEREAS, the updated Historic Preservation Plan is intended to serve as a non-regulatory, advisory policy document to guide future actions, grant applications, and public engagement regarding historic preservation in the City of Astoria;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ASTORIA:

<u>Section 1</u>. The City of Astoria hereby adopts the 2025 Astoria Historic Preservation Plan as an official guiding policy document to support the city's historic preservation goals and initiatives.

<u>Section 2</u>. The Plan shall serve as a non-binding resource to inform staff, decision-makers, and the public, and may be used to guide future updates to the City's Comprehensive Plan, zoning code, or related efforts.

<u>Section 3</u>. The Community Development Department is directed to publish the Plan on the City's website and retain it in official planning files for public reference.

Section 4. This Resolution shall take effect immediately upon adoption.
