

A RESOLUTION AMENDING APPROPRIATION IN THE FISCAL YEAR 2024-2025 FOR THE GENERAL FUND

WHEREAS, ORS 294.338(3) provides guidance to amend the budget for a specific purpose or purposes, and

WHEREAS the City Attorney was contracted to do additional work not covered in his regular contract, and

WHEREAS the circumstances requiring the expenditure could not have been foreseen at the time of the preparation of the budget for the current year, and

WHEREAS, a resolution authorizing the acceptance of grant funds to the General Fund is required after adoption of the FY 2024-2025 budget.

WHEREAS, the adjusted budgets are on file in the office of the Director of Finance and Administrative Services at City Hall.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ASTORIA:


Authorizes the transfer of \$8,000 from the contingency in the General Fund to the City Attorney section in the General Fund #001-1800-620-4355. The total appropriation amount in the fund remains unchanged at \$19,617,270.


