

#### Clean Water Act Permits:

#### National Pollutant Discharge Elimination System (NPDES)

- NPDES permits allow discharge of pollutants to surface water
- Oregon was delegated authority to implement the NPDES program in 1973

#### **General Permits**


- Similar discharges
- Generally smaller
- Specific requirements for large groups of applicants
- For example: industrial or construction stormwater

#### **Individual Permits**

- Site-specific criteria
- Industrial and domestic (POTW)
- Technology and water quality-based effluent limits
- Implement Total Maximum Daily Load (TMDL)
- State and federal requirements

#### Importance of Current Permits

- Monitoring requirements and limits reflect current standards and guidelines
- Changes in effluent limits are incremental
- Prepare for complex compliance issues
- Recent data represents current performance
- Permit reflects current operations
- Permits can be updated to support facility planning and upgrades




### Water Quality Permitting Program Goals

- Program goals for NPDES Individual permits
  - Current permits greater than 90%
  - Planning
  - Standardization
  - Data availability
  - On time
  - Continuous improvement planning, metrics, and reporting




#### Oregon NPDES Individual Permit Backlog: 2006 to Present





# 2020 Status of NPDES Individual Permits


- As of Aug. 12, 2020:
  - 89 permits current
  - 86 permits out of date less than 5 years
  - 81 permits out of date more than 5, less than 10 years
  - 59 permits out of date more than 10, less than 15 years
  - 16 permits out of date more than 15 years






## **Current Status of NPDES Individual Permits**

- As of June 16, 2025:
  - 142 permits current
  - 25 permits out of date less than 5 years
  - 57 permits out of date more than 5, less than 10 years
  - 40 permits out of date more than 10, less than 15 years
  - 43 permits out of date more than 15 years

# Water Quality Based Limits

- Basin Standards
  - State design criteria
    - OAR 340-041-0101 through -350
    - These can be site or regional specific
- Water Quality Standards
  - 2022 Integrated Report and impairment listings
  - 2024 submitted for approval
    - Implemented in new and renewed permits

- Waste Load Allocation (from TMDL)
  - Various pollutants for impaired water bodies
  - Statewide focus on temperature TMDL updates
    - Implemented in new and renewed permits after approval



## Permit Development

- Process includes front-loaded subject matter expert (SME) reviews
  - Permit writers are required to review complex topics with SME's
  - SME reviews are approved prior to QA and back-end processes (QA, applicant review, public notice)
- All permits receive internal quality approval prior to back-end processes
- Permit issuance is a priority for the agency → "Issue permits" topdown communication
  - Your DEQ Online is a competing priority while the program works on testing



# Permit Development – Challenges

- 1. Multiple vacancies from 2021 to 2024
  - Team of 10 permit writers
  - Hired and trained 9 out of 10 permit writers
- 2. Permitting culture shift internal and external
  - Centralized permit development produces consistent application of CWA and OARs for all NPDES permits
  - Standardization of permit development through updated internal management directives, quality assurance check points, direct support guidance
- 3. Technology
  - Your DEQ Online
  - Cyberattack



#### Consent Judgement (Final Date Nov. 18, 2018)


- Continued focus and integration
- Completed tasks
  - Various administrative general permit issuance
- Annual WQ Report on Individual NPDES Permits sent to EQC on Jan. 1
- Backlogged permits

| Milestone | Percent Complete | Status   |
|-----------|------------------|----------|
| 2 years   | 10%              | Complete |
| 4 years   | 25%              | Complete |
| 6 years   | 40%              | Complete |
| 8 years   | 75%              |          |
| 10 years  | 100%             |          |



# **Consent Judgment Permits**

- Backlog settlement: 148 permits
- Milestone: 75%
  complete by
  November 2026
- As of June 16, 2025: 85/148 complete (57% complete)





# NPDES Individual Permit Issuance Plans

- On Oct. 1 of each year, DEQ publishes a permit issuance plan that identifies the permits targeted for development during the next year and for the next five years
- Work plan developed internally
  - Rollover permits
  - Permits soon to expire
  - Regionally priorities
  - Geography
  - Resource availability
- Final NPDEQ Individual Permit Issuance Plan posted in October
- NPDES and WPCF General Permit Issuance Plan
