5. PRESENTATIONS/PROCLAMATIONS

AUDIENCE PARTICIPATION

Eric Wingbermuehle with Urban SDK company gave a presentation on their software that provides real-time location analytics to help smart cities transform mobility, transportation, sustainability and safety operations. The software connects public agencies, policy makers and the community with better data for informed policy and budgeting decisions.

TSC members were very interested in the information collected. At the end of the presentation Mills told the commission the Public Works Department is currently using a program called RITUS (which stands foe Regional Integrated Transportation Information System). RITUS, which is a free version of a program that tracks cars and their movements, similar to the Urban SDK presentation. The program

RITUS is from the State of Oregon and the city has been very pleased with the information gathered. Mills will connect with Holloran and Carrico and give them the information so they can sign up for the RITUS program too.

6. STAFF REPORTS

A. TRANSPORTATION DIVISION MANAGER REPORT

- 1) David Mills, introduced James Sprague, the City's new Transportation Manager.
- 2) Sprague reported the crack seal program is ongoing.
- 3) The upcoming paving projects are 1st Street parking lot June 2nd through June 4th
- 4) The annual chip seal project is scheduled for the week of June 16th.

B. <u>CITY POLICE REPRESENTATIVE REPORT</u>

Carrico reported the police department is very close to having all of their positions filled.

C. CITY CODES ENFORCEMENT OFFICER REPORT

- 1) Autry reported they are receiving many complaints of trailers and motor homes parked on the street. There is a permit form on the City's website that allows for on street parking for a short amount of time. There is no cost for this permit.
- 2) The letters of abatement for trees and vegetation around town are starting to be sent to property owners.

D. CITY ENGINEERS REPORT

- 1. Bosse reported there are currently two ongoing projects. The 6th Street Widening Project and the Basalt Commons 3rd Street Plan Review Project are both happening right now.
- 2. Bosse said the Safe Routes to School (SRTS) project will begin in June.

- B. Kilkenny brought up a concern from Commissioner Brown about the dangerous situations that occur when bikes, e-bikes and skateboards use the sidewalk, especially in the downtown area. What can citizens do about it? A reminder helmets are supposed to be worn by children 16 years old and younger.
