**Subject:**

2002 E-One Engine #6201 refurbishment.

**Recommendation:**

Motion to authorize the Fire Department to have the 2002 E-One Engine #6201 refurbished by Fire Trucks Unlimited, for \$338,694.00, and to authorize the Finance Director to enter into a financing agreement for this vehicle refurbishment.

**Financial Impact:**

The cost for the fire truck refurbishment is \$338,694.00.

**Background/Discussion:**

The refurbishment of our 2002 E-One pumper truck has numerous benefits. Equipment-wise, all emergency lighting will be replaced with LEDs, the fire pump and all plumbing will be replaced, the brakes upgraded, steering, and suspension parts will be replaced, along with other improvements. Appearance-wise, the interior will be new and the truck will receive a new paint job. With everything that is being replaced and upgraded we can expect another 15-20 years of service life from this apparatus. The Type-3 fire engine we were awarded by OSFM last year will be used in place of the E-One during the approximately 5-month refurbishment.

This pumper truck refurbishment was discussed during the budget process and the Council approved it as part of the current budget. Quotes were requested and received from the two closest refurbishment companies.

Staff recommends having the fire truck refurbishment performed by Fire Trucks Unlimited who was the higher bidder. Per the City of Brookings procurement policy it is permissible to purchase from a higher bidder when factors including quality of work and warranty are considered.

Fire Trucks Unlimited has been recommended by the Fire Chief of Charleston Fire Department who had used both Fire Trucks Unlimited and US Fire Equipment for engine refurbishments. He advised that he would not recommend using US Fire Equipment citing unsatisfactory work and issues that continued for years after the refurbishment. This chief also stated that he was very impressed and pleased with the work and professionalism from Fire Trucks Unlimited. Fire Trucks Unlimited also has a stated 1 year

warranty as well as ongoing support that US Fire Equipment has not provided. This factor was also reiterated by the Chief of Charleston in his endorsement of Fire Trucks Unlimited.

In addition to the above inspection, a chassis dynamometer test shall be done to assess the condition of the motor and its subsystems. - 19) If the exhaust system is not scheduled to be repaired or replaced then a thorough inspection shall be performed including inspections for leaks, loose hangers, rusted tubing, wear, or other problems that could affect the performance of the exhaust system. The refurbishment center shall notify the purchaser in writing of any problems discovered during the inspection.
- 20) Replace Muffler – The muffler shall be replaced with a new, meeting OEM specifications.
- 21) Replace Wrap, Flex, & Tip – The exhaust wrap shall be replaced with new high temperature insulation wrap. Damaged flex plumbing shall be replaced with new and clamps replaced if necessary. The exhaust tip shall be replaced.

#### **Axles**

- 22) Front Axles (2X4) – The front axles shall be removed and inspected for wear. The bearings shall be replaced and lubed. New wheel seals shall be installed.
- 23) Rear Axles – The rear axles shall be removed and inspected for wear. The rear end shall be disassembled and inspected including the third member. Tolerance shall be reset. A new pinion seal and new wheel seals shall be installed. Wheel bearings shall be replaced and lubed. Any third member damage shall be reported to purchaser.

#### **Braking System**

- 24) **Replace Break chambers, Shoes, Drums, and Slack Adjusters** – The front and rear brakes shall be replaced to include two brake chambers, shoes, drums, s cam bushings, and all slack adjusters. The components shall meet OEM specifications.

#### **Suspension, Wheel & Tires**

- 25) **New Springs, Pins, Bushings & U-Bolts** - The front and rear spring suspension shall be replaced with new components meeting OEM specifications including GVWR, GCWR and GAWR ratings. Replaced components including spring, pins, bushings, and U-bolts. The front shocks shall be replaced with new, meeting OEM specifications.

#### **Steering**

- 26) **If certain parts of the steering system are not scheduled to be repaired or replaced**, then a thorough inspections of the power steering pump, hose, and accessories shall be performed including inspecting for wear, leaks, loss of performance, and other problems. The refurbishment center shall notify the purchaser in writing of any problems discovered during the inspection.
- 27) **Tie Rod Ends** – the tie rod ends shall be replaced with new, meeting OEM specifications.
- 28) **Drag Link** – the drag link shall be replaced with new, meeting OEM specifications.
- 29) **Steering Gearbox** – The power steering gearbox shall be replaced with a remanufacturing gearbox meeting OEM specifications. The box shall be refilled with fluid and steering tolerance shall be reset.

#### **Transmission – Inspect & Advise 3000 Series**

- 30) **If the transmission is not scheduled to be repaired or replaced**, then a thorough inspection of it shall be performed including inspecting for wear, damage, and fluid leaks. All fluid levels will be checked. The refurbishment center shall notify the purchaser in writing if any problems discovered during the inspection.

#### **Low Voltage Electrical System & Warning Devices**

- 31) **Alternator** – The alternator shall be replaced with a new one meeting OEM specifications.
- 32) **Batteries** – The batteries (6) shall be replaced with new Group 31 Batteries.

- 33) **Battery Charger** – A new Kussmaul 40 amp Auto Charge 1200 with remote display (091-187-12-REMOTE) battery charger shall be installed. Remote display shall be mounted on the rear of the driver side front door.
- 34) **Auto Eject** – A new Kussmaul 120 volt 20 amp Super Auto Eject (091-55-15-DC) shall be installed on rear of the driver side front door, cover will be red.
- 35) **Heavy Gauge Wiring** – the wiring from the batteries to the starter shall be replaced with new, meeting OEM specifications.
- 36) **Chassis Wiring Harness** – The chassis wiring harness shall be inspected to include the condition of wires, connectors, relays, fuse and/or circuit breakers, and related components. The chassis wiring system shall be repaired including chaffing, shorts, loom, frayed wires, bad connections, and faulty components.
- 37) **Body Wiring Harness** – the body wiring harness shall be inspected to include the condition of the wires, connectors, relays, fuses and/or circuit breakers, and related components. The body wiring system shall be repaired including chaffing, shorts, bad connections, and faulty components.

#### **Lighting, Signals, Horn**

- 38) **Warning Lights, Zone A Upper** – The light bar shall be removed and replace with a new Edge Freedom IV F4W WeCan Series Super LED Light bar. The light bar shall be populated with eight (8) red forward facing flashing LED modules and four (4) side facing flashing LED modules, lens shall be clear.
- 39) **Warning Lights, Zone A Lower** – The forward facing emergency lights shall be replaced with two (2) Whelen 4V3R 400 Series Linear Super LED Lights and two (2) Whelen C6 Series Super LED light heads. The LED color and lens could shall be red. The light heads shall be mounted either in a common bezel with front facing turn signals or in a separate chrome bezel.
- 40) **Warning Lights, Zone B/D Upper** – The upper B/D zone emergency lights shall be covered, the light bar and rear beacons.
- 41) **Warning Lights, Zone B/D Lower** – The side facing emergency lights shall be replace with six (6) Whelen 5V3R lights 500 Series Linear Super LED. The LED color and lens color shall be red. The light heads shall be mounted in a chrome bezel.
- 42) **Warning Lights, Zone C Upper** – the rear upper warning lights shall be replaced with (2) Whelen L31 Series Super LED Beacons. The LED color and lens color shall be red. The light head shall be mounted on compartment tops or on a pedestal.

- 43) **Warning Lights, Zone C Lower** – The rear facing emergency lights shall be replaced with four (4) Whelen 5V2R/5V3A 500 Series Linear Super LED light heads. Two (2) LED color and lens color shall be red and two (2) LED color and lens color should be amber.
- 44) **Clearance/Marker Lighting** – The clearance lighting shall be replaced with new LED light heads similar in shape and size to the original clearance lighting.
- 45) **Ground Lighting** – Ten (10) new 4” round white LED constant duty light heads shall be installed under the apparatus in stepping areas. The lighting shall be mounted in the angled bracket below the cab doors (4), below the pump panel (2), below the rear of the body on the drivers and passengers side (2) and below the rear of the apparatus (2). Puddle lights from the Whelen 4V3R and 5V3R lights will also illuminate the ground around the apparatus.
- 46) **Compartment Lighting** – The compartments (6) shall have full-length Fire Research LED strip lights installed on both vertical frames of the compartments. The compartment lights shall be illuminated when the compartment door is open and turned off when the compartment door is shut.

The light heads shall be 20,000 lumens each. The poles shall be mounted on the back of the cab unless otherwise noted. The pole lights shall be operated by a switch located near the pole.
- 50) **Reflectors** – The red and amber reflectors shall be replaced with new meeting DOT standards.
- 51) **Air Horn** – The air horn shall be removed and rebuilt with new seal kits. The air horn shall be polished and re-installed.

## **Driving & Crew Compartments**

- 52) Instrumentation/ Gauges – The cab instrumentation shall be inspected and tested for proper operation. If the instrumentation is not functioning correctly, the refurbishment center shall notify purchaser in writing of any problems discovered during the inspection.**
- 53) Windshield – The windshield washing system shall be overhauled to include new blades, hoses, nozzles (if necessary), and fluid.**
- 54) Driver's Seat - The driver's seat shall be replaced with a new H.O Bostrom Sierra Air ride seat with grey durawear material.**
- 55) Officer's Seat – The officer's seat shall be replaced with a new H.O Bostrom SCBA seat with grey durawear material.**
- 56) Rear Facing Crew Seat – The rear facing crew seats (2) shall be replaced with H.O Bostrom Tanker 450 SCBA seats with grey durawear material.**
- 57) Forward Facing Crew Seat – The forward facing crew seats (2) shall be replaced with new H.O Bostrom CBA seats with grey durawear material.**
- 58) Seat Belts – The seat belts (6) shall be replaced with new NFPA compliant red seat belts and receivers, meeting OEM specifications. If seat belt monitoring system is to be installed the appropriate receivers will be purchased.**
- 59) Warning Stickers – The required safety labels inside the cab and around the apparatus shall be replaced with new.**
- 60) Cab Hardware – Broken or missing cab hardware including latches, A/C louvers, clips, hooks, switches, and brackets shall be replaced as necessary.**

## **Body, Compartment, & Equipment Mounting**

- 61) Entire Body, Subframe, & hosebed – The entire body, subframe, and hosebed shall be inspected for wear, cracking, damage, and corrosion. The refurbishment center shall notify the purchaser in writing of any problems discovered during the inspection.**

- 64) **Diamond Plate** – All non-welded diamond plate shall be removed and cleaned where possible. Diamond plate shall have a new appearance.

- 65) **Steam Cleaning** – Prior to body work and prepping, the apparatus shall be completely steam cleaned to remove all debris, dirt, oil, grease, and other contaminants.
- 66) **Body Work** – The cab and body shall be inspected for damage and imperfections. Minor dents and scratches will be filled, smoothed, and sealed. Minor cracks shall be re-welded, grinded, and sealed. Surface rust will be treated and sealed. Holes shall be filled in where the headlights used to be on the cab. Major bodywork and corrosion shall be identified and reported to the purchaser.
- 67) **Frame Rails** – The Frame rails shall be inspected and surface rust shall be treated.
- 68) **Compartments** – The compartment interiors shall have all mounting brackets removed. Holes not used that are not to be reused shall be welded and grounded down. The compartment interiors shall be refinished with a heavy-duty grey zolatone finish. Compartment shelving shall be refinished with grey zolatone. Interior of compartment doors shall remain job color.
- 69) **Paint Surface Preparation** – Prior to paint preparation, all bolts on compartments shall be removed including but not limited to; door handles, lighting, bezels, grab rails, steps, trim, front grill, side grills, mirrors, pump panels, diamond plate, hose beds, water tank, fenderettes, D rings, rub rails, ladder rack, etc. The body except roll up doors will be finish sanded using a multistep sand process and prepared for final paint. Upon completion of final preparation, the body will be painted utilizing the highest quality, state of the art, low V.O.C., polyurethane base paint. Finish paint will be applied in multiple coats to ensure proper paint coverage with high gloss finish. The entire body will be buffed and detailed.
- 70) **Primer & Preparation** – After sanding is finished the body shall be sealed and a primer coat shall be applied. After priming, the paint surface shall be finished and sanded in preparation for final coat.
- 71) **Cab** – Upon completion of final preparation, the cab will be painted utilizing the highest quality, state of the art, low V.O.C., polyurethane base paint. Finish paint will be applied with a minimum of three coats to ensure proper paint coverage with a high gloss finish. The entire cab will be color sanded, buffed, and detailed.

- 79) **Intake Screens** – The pump intake screens shall be replaced with new.
- 80) **Pump Panels** – The pump panel shall be completely disassembled including removal of gauges, valve linkage, caps, plumbing, placards, throttle, etc. The pump panel shall be cleaned prior to re-assembly.
- 81) **Color Coded Tags** – Damaged or missing color coded identification tags shall be replaced with new.
- 82) **Cap & Chains** – The discharge caps and chains shall be replaced with new chrome caps and chains.

### **Foam System**

- 83) **New Foam Proportioner** – A new FoamPro 2001 Automatic Foam injections system shall be installed on the apparatus complete with a flowmeter, foam pump, microprocessor control/display unit, strainer, and check valve. The foam system shall be plumbed to (2) speed lay, bumper line and (1) rear 2.5" discharge.
- 84) **Foam Level Gauge** – A class A foam level gauge shall be replaced with a new FRC LED tank vision foam level gauge. The new gauge shall have a new sending unit installed.

### **Water Tank**

- 85) **Water Level Gauge** – The water level gauge shall be replaced with a new FRC LED tank vision water level gauge. The new gauge shall have a new sending unit installed.

### **General**

- 86) **Assembly** – Upon completion of mechanical overhaul and paint, items previously removed and not specifically addressed in the above statement of work shall be re-installed on vehicle including cab rails, rub rails, emergency lighting, DOT lighting, scene lighting, diamond plate, steps, bumpers, tow hooks/eye, doors, reels, monitors, brackets, shelving, ladder rack, hard suction mounts, door handles, door hardware, panels, mirrors, windshields, speakers, air horns, fenderettes, and grills.
- 87) **Wash & Detail** – Prior to every delivery of vehicle, the interior and exterior shall be cleaned and detailed. The finalization process detailing will include installation of NFPA required labels, checking fluid levels, sealing and caulking required areas of the cab and body, rust proofing, paint touch-up, etc.





### **Subject:**

Fire Operations Chief pickup truck purchase.

### **Recommendation:**

Motion to authorize the Fire Department to purchase one pickup truck from Roberson Motors, Inc., for \$43,126.50, and to outfit it at Cascade Fire and Equipment for \$20,803.54 and to authorize the Finance Director to enter into a financing agreement for this vehicle.

### **Financial Impact:**

The cost for the pickup is \$43,126.50. The outfitting cost is \$20,803.54.

### **Background/Discussion:**

This pick-up will provide the extra room needed to carry all necessary equipment for Incident Command. Along with a command board and a second radio installed in the back, it will also have the needed room to carry rope rescue equipment, medical equipment, and additional personnel. This truck would also offer more ability to access and respond to emergencies in some of our more remote areas. The current 2013 Durango is 12 years old with high mileage and does not have the needed capacity.

This pickup for the Fire Operations Chief was discussed during the budget process and the Council approved it as part of the current budget. Roberson Motors Inc., has the State of Oregon Statewide Price Agreement for these vehicles. Statewide Price Agreements offer discounted rates that are already negotiated by the State of Oregon. This is allowed in our City Procurement Policy. Most City vehicles are Dodges and Dodge is our choice for this pickup due to platform commonality and for current maintenance agreements. We did, though, request bids from Dodge, Ford, and Chevy and found the Dodge to be the lowest bidder.

The Fire Department solicited bids to outfit the pickup. The bids received were:

Cascade Fire Equipment	\$20,803.54
LEHR	\$20,085.17
Wire Works	\$22,271.41

Staff recommends purchasing the fire pickup from Roberson Motors, Inc. who was the lowest bidder and outfitted by Cascade Fire Equipment, who was the second lowest bidder. Per the City of Brookings procurement policy it is permissible to purchase from a higher bidder when certain factors are considered.

Cascade Fire Equipment (White City) provided a build timeline that is approximately 6 months earlier for a finished product than LEHR (Salem) who was the lowest bidder. Cascade Fire Equipment is also much closer in proximity allowing for servicing or maintenance to be accomplished with less travel time.



CH2M Hill Engineers Inc. (Jacobs Engineering) Amendment No. 2 to the Amended and Restated Agreement for Operations Maintenance and Management Services

### Recommended Motion:

Motion to authorize the City Manager to sign Amendment No. 2 for CH2M Hill Engineers commencing July 1, 2025 and concluding June 30, 2026.

### Financial Impact:

The total cost for this base fee with adjustment is \$1,875,449 and is included in the 2025-2026 budget.

### Background/Discussion:

On May 22, 2023, the City entered into a 10-year service contract with CH2M Hill Engineers (Jacobs Engineering) for Operations, Maintenance, and Management for treatment services.

Jacobs provides all employees and supplies to staff the water and wastewater treatment plants, sewer lift stations, water pump stations, and water storage tanks. The City owns the facilities and equipment, which are maintained by Jacobs.

This contract has proved to be beneficial to the City, in cost savings over previous operating costs, eliminating the challenge of staffing certified operators, and transferring liability to Jacobs.

This yearly base fee with adjustment, Amendment No. 2, outlined in the contract, is determined from the twelve-month percent change (from October of the prior year to October of the current year) in the Consumer Price Index for All Urban Consumers: Water and Sewer and Trash collection services.





Motion: Authorize City Manager to purchase a used greens mower from Turf Star Western in the amount of \$32,000

Financial Impact: \$32,000 from Capital Projects Reserve Fund

Background/Discussion:

CourseCo is requesting the City consider replacing the greens mower at Salmon Run Golf Course. The greens mower they currently use has been there since the course opened (circa 1999), requires considerable maintenance annually to keep it going, has over 18,000 hours on it, and parts for repairs are becoming less and less available.

The management agreement between the City and CourseCo stipulates the equipment is owned by the City and used by CourseCo staff. There is a \$50,000 capital fund established annually during the budget process to be used for projects and equipment at Salmon Run.

CourseCo staff reached out to three separate golf course equipment suppliers to solicit quotes for a used greens mower. They are recommending the City consider purchasing the used (2016) greens mower from Turf Star Western in the amount of \$32,000.
