A RESOLUTION OF THE CITY OF ASTORIA, OREGON, AFFIRMING SUPPORT OF
A GRANT APPLICATION TO THE OREGON DEPARTMENT OF LAND
CONSERVATION AND DEVELOPMENT.

BE IT RESOLVE BY THE CITY COUNCIL OF THE CITY OF ASTORIA:

A RESOLUTION of the City of Astoria affirming the City's intent to complete a state-mandated Housing Capacity Analysis and to partner with the Department of Land Conservation and Development for technical assistance and funding support to carry out this essential housing planning work.

WHEREAS, the Oregon State Legislature, through House Bill 2003 (2019) and Oregon Revised Statutes 197.296 and 197.293, requires cities with populations over 10,000 to complete a Housing Capacity Analysis (HCA) to evaluate whether their Urban Growth Boundary can accommodate the housing needs of current and future residents over a 20-year period; and

WHEREAS, the HCA will provide the City of Astoria with critical data and analysis to support equitable, efficient, and effective planning for housing of all types, sizes, and affordability levels; and

WHEREAS, the City of Astoria's HCA will inform future zoning and policy decisions, help identify infrastructure constraints, and guide the development of a Housing Production Strategy to support long-term housing goals; and

WHEREAS, the Oregon Department of Land Conservation and Development (DLCD) offers grant funding and technical assistance to cities to support completion of Housing Capacity Analyses and related planning tasks; and

WHEREAS, the City of Astoria intends to apply for DLCD Housing Planning Assistance funding for the 2025–2027 biennium to undertake a Housing Capacity Analysis with consultant support and in coordination with local and regional partners; and

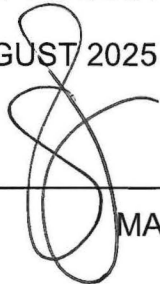
WHEREAS, the Astoria City Council supports this application and the City's commitment to contributing staff time, facilitating public engagement, and using the results of the HCA to inform policy and implementation efforts.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Astoria, Oregon, that:

1. The City of Astoria supports the submission of a Housing Planning Assistance grant application to DLCD for the purpose of completing a Housing Capacity Analysis.
2. The City affirms its commitment to contribute staff time and resources necessary to successfully complete the project.
3. The City Manager or designee is authorized to execute all documents and agreements necessary to apply for and accept the grant award.

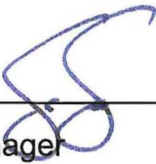
