RE: No Further Action Determination for Main Street Mini Mart – Boardman

In Boardman, Morrow County

[LUST # 25-25-0283]

Dear Alex Hattenhauer:

The Oregon Department of Environmental Quality (DEQ) has completed a review of the available information and the suspected release investigation documentation, dated June 12, 2025 and submitted to DEQ on your behalf. Main Street Mini Mart – Boardman (site) is located at 100 Main St N, Boardman [Tax Lot 4100; Township 4 North; Range 25 East; Section 9-CB].

DEQ has determined that remedial action to address environmental contamination at Main Street Mini Mart – Boardman is complete, and no further action is required. This determination is based on the DEQ regulations and the facts as we now understand them including, but not limited to the following:

- The site is currently an active petroleum fueling facility (UST Facility 5066).
- Main Street Mini Mart Boardman reported a suspected release on May 21, 2025.
- An investigation of the suspected release indicated that there was no release to the environment.

Based on the available information, Main Street Mini Mart – Boardman is currently protective of public health and the environment. The site requires no further action under the Oregon Environmental Cleanup Law, ORS 465.200 et seq. and under Oregon Administrative Rules (OAR) 340-122-0205 through 340-122-0360 unless new or previously undisclosed information becomes available, or there are changes in site development or land and water uses, or more contamination is discovered. DEQ will update the Leaking Underground Storage Tank (LUST) database to reflect this decision.

If any contaminated soil or groundwater is encountered in the future, it must be handled and disposed of in accordance with local, state and federal regulations. If present, monitoring wells should be maintained or decommissioned in accordance with Oregon Water Resources Department regulations.
