

MINUTES

Minutes of a meeting of the Committee on Fire and Water, otherwise known as the Water Committee of the Common Council of the City of Newberg, held at the office of Herbert Swift, city attorney, in the City Hall Building, Newberg, Oregon, on January 2, 1947, at 7:30 o'clock p.m.

The meeting was called to order by Chairman Russel Gainer. Those present were Russel Gainer, chairman, Mrs. Ethel Palmer and Charles Scott, being all of the members of said committee.

The matter of summer sprinkling rates by commercial consumers of water was discussed and an amendment to Ordinance No. 888 of the City of Newberg covering this matter was drafted and ordered presented to the Council.

Similar action was taken relative to the definition of a commercial consumer in said ordinance.

The Committee then adopted the following resolution regarding cost of water connections, to-wit:

RESOLUTION

WHEREAS it is provided by Ordinance No. 888 of the City of Newberg, a municipal corporation of the State of Oregon, that the Committee on Fire and Water, otherwise known as the "Water Committee" of the Common Council of said City shall determine and fix a schedule of charges to be paid by applicants for water service from the said City to cover the cost of the connection with the water system; and

WHEREAS the undersigned Russel Gainer, chairman, Ethel Palmer, and Charles Scott are all of the duly appointed, qualified and acting members of said Fire and Water Committee; and

WHEREAS said Committee has met and has considered the cost of such connections, and has taken into consideration the question of whether such connection or tap is or is not located beneath hard surface pavement and also whether or not same is located within the corporate limits of the said City of Newberg and also the size of the connection desired and such other matters

as may properly affect the cost and expense of such connection; now, therefore,

BE IT RESOLVED BY THE FIRE AND WATER COMMITTEE OF THE COMMON COUNCIL OF THE CITY OF NEWBERG that the following schedule of charges shall be the amount to be paid by applicants for water service for the installation of the connection with the water system of the City of Newberg in the manner provided by said Ordinance No. 888 of said City and that this schedule shall be effective immediately:

Where said applicant and the place where the water is to be used are located within the corporate limits of the City of Newberg and the connection is not located under hard surface pavement, such cost shall be the sum of - - - - - \$ 35.00

Where said applicant is located as aforesaid but such connection is under hard surface pavement such cost shall be - 45.00

Where the applicant and the place where the water is to be used are outside the corporate limits of the City of Newberg, the charge for the services required of the City of Newberg in making the connection in accordance with the terms of said Ordinance No. 888 shall be the sum of - - - - - 5.00 plus the cost to the City of all materials used.
