Travis Hultin, Public Works Director, gave a brief overview of the staff report and shared a PDF (attached as Exhibit B).

Mayor Ripma stated it would take 3 or 4 of the sampled homes exceeding .010 to trigger the 24-hour notification.

Travis Hultin stated that's right.

David Schaffer, Public Works Superintendent, stated he's not totally sure but he thinks it will be multiple samples.

She asked about how apartment buildings are tested. She stated that her apartment buildings water was shut off for 4 hours and when it was back on the water was brown.

David Schaffer stated the building owner would have to do the sampling there because the infrastructure is newer.

Councilor White stated that that location is using the street as a laydown yard. He thinks they have enough land that they could gravel and use for staging. He heard a letter was sent to Gresham Fire from the 3 Cities and he would like to get a copy of that letter. Some committee members were upset they didn't get to see that letter first.

Mayor and Councilors,

I would remind Council that in selecting a Council President it's not only someone who "fills in" when the Mayor is occasionally absent, but because a Mayoral vacancy must be filled by election, in the event of an extended absence by the Mayor the Council President could be serving as the "acting" Mayor for six months or longer. In 1993 a newly-elected Mayor resigned in the fourth month of his two-year term. At the time the Charter called for filling a Mayoral vacancy the same as Councilor vacancies are currently filled, appointment by the Council. The prospect of a nearly twoyear Mayoral appointment was a controversial possibility. However, that was the only option under the 1942 Charter. Of course, that appointed Mayor went on to be a long-serving elected Mayor. A change would have required a charter amendment, which would have had to precede acting on the amendment. The issue raised enough interest and concern that the newly-appointed Mayor called for a full-fledged charter review, which did occur in 1994, resulting in the current charter, which of course changed the Mayoral term from two to four years and calls for a Mayoral vacancy to be filled by election, among other changes. It's noteworthy that those two changes in particular were controversial in that they were included in the new charter on a 4-3 Council vote. With a new charter the voters' only option is all or nothing.

I'd encourage the Council to review the Council meeting minutes from that time, particularly April 27, 1993 and May 25, 1993. Current actions required bear some real similarities to that period.



January 14, 2025 Council Meeting Minutes

Mayor and Councilors,

First off, I wanted to correct some factual errors in the staff report under background. Councilor Ripma was sworn-in as a Councilor in January 2023, not 2022. He filed by fee to be a Mayoral candidate on July 16th 2024, early summer, not fall.

Secondly, I had taken issue with the proposed transition process for Mr. Ripma to go from Councilor to Mayor. However, he did resign, as I had requested. An applicable city charter statement would be "An elective office of the city shall be deemed vacant before the expiration of the term upon the incumbent's taking the oath of office of another elective governmental office." The problem is that's language from the Gresham City Charter. There is no similar language in the Troutdale City Charter. Resignation was the most straightforward route.
