Mayor Ripma read the proclamations.

5.1 RESOLUTION: A resolution accepting the recommendation of the Well #9 siting study.

Travis Hultin, Public Works Director, joined by Scott Waddell, Civil Engineer, gave a brief overview of the staff report.

Mayor Ripma asked if the well house can be modest in size.

Travis Hultin replied yes, he would like it to look aesthetic in the neighborhood.

Councilor Andrews asked if nearby residents have been notified.

Travis Hultin replied not yet. Staff wanted to talk to Council first before getting feedback from residents.

Council Andrews asked if there are any noise issues.

Travis Hultin stated there haven't been any complaints about noise from the Well #5 site, which is very near a number of houses in that neighborhood.

Councilor White asked if there is any danger of trace minerals showing up like in Well #4 that smells like rotten eggs.

Travis Hultin stated he doesn't expect it but well drilling is tricky, and you can drill a well and get a great water source and then you can go 100 yards away and drill a well and get a pocket of weird geology and you don't get so great of results. You never know until you drill.

Mayor Ripma asked if Council approves the resolution and then hear a big cry from the neighborhood, is the Council stuck?

Travis Hultin replied no, the Council can always change their mind.

Ray Young gave a brief overview of the staff report.

Norm Thomas, Mt. Hood Cable Regulatory Commission, stated this process has taken several years to get to a finalized franchise agreement. His hope is that it will get approved.

Andrew Speer, Franchise Utility Program Manager MHCRC, presented a PowerPoint (attached as Exhibit A).

Mayor Ripma stated he met with a representative with MetroEast, and they all feel this is the best deal that Troutdale will get.

Councilor Wunn asked what the consequences would be if Council didn't approve the resolution.

Norm Thomas stated one of the first consequences could be that they shut off cable altogether and there would be no services until everything is resolved. If it goes back to negotiations, it could be worse.

Andrew Speer stated that Comcast uses the cable franchise agreement as a way to get its bundled services across the same line so broadband would be part of that. If you don't have an active cable franchise, then you have someone in the right of way illegally then you need to work through that. If there was an issue in the right of way related to their construction or whatever it might be, you wouldn't have a legal contract to execute.

Ray Young asked if the City said no, does the City have the right to negotiate its own agreement and what would that entail?

Andrew Speer stated as part of the IGA between the jurisdictions and the cable commission the cable commission is just recommending it and the commission voted to adopt the recommendation. The work as the cable commission is done and then the cities have to execute on the recommendation yes or no. He thinks of it as a legal exercise.

Councilor Allen asked how the City pays.

Mayor Ripma stated it's a franchise agreement fee and Comcast pays for the right to provide cable:

Ed Trompke, City Attorney, stated the Home Forward development has an entrance on 4th Street. The gated entrance was requested but it needs to be there for flow of vehicles.



Cable Franchise Agreements: What They Do

A franchise agreement is a legal contract between a local jurisdiction and a cable provider that grants access to operate in the public Right-of-Way (ROW). These agreements ensure that cities receive compensation, regulatory oversight, and public benefits.

Key Features


- i. Typically, 5 to 20 year agreements
- ii. Compensation for access and use of the ROW (5% of gross revenues) (Franchise Fees)
- iii. Includes customer service standards and compliance reporting
- iv. Requirements for broadcasting Public, Educational, and Government (PEG Fees)
- v. Can include other special provisions as negotiated b/t parties





Cable Service Landscape: Declining Subscriber Base

The cable industry has experienced a **steady decline in subscribers since 2016**, reflecting shifting consumer preferences and increased competition from streaming services. The most recent data **reports fewer than 88,000 cable subscribers in the region**, a significant drop from previous years.

To mitigate revenue loss from declining subscriptions, cable providers have implemented price increases, helping to slow the overall impact on gross revenues. However, these trends indicate a long-term shift in how households access digital content, requiring adaptive strategies for sustaining public benefits tied to cable franchise agreements.

Comcast Franchise Background



Comcast Franchise Renewal Process

Federal law, FCC regulations, and local agreements require the City of Portland to maintain a cable franchise agreement. These agreements ensure that cable providers have legal access to operate within the city's public right-of-way, while also securing funding and enforcing compliance measures to protect community interests.

Cable Negotiations with Comcast (started in 2020)

Key Negotiated Items (in 2025):

- **PEG Fee Increase** The negotiated PEG (Public, Educational, and Government) fee is set to increase from **1.25%** (2023) to 2.5%, ensuring continued funding for community media.
- FCC Order 621 Compliance Cable providers can recover marginal costs, as permitted under the 2019 FCC ruling.
- **Legal Compliance** The agreement complies and aligns with all federal cable service laws to ensure regulatory adherence.
- Gross Revenue GAAP Changes Gross revenue reporting follows GAAP standards, with transparency through an established audit process, allowing for reporting on changes.
- I-NET Removal References to I-NET have been removed to align with updates regulations.
- Records Review The agreement limits record review to the duration of the contract, ensuring clear oversight.
- Information and Reports Ensures data security and sets clear expectations between grantor and grantee.
- Updated Notification Process Revisions now permit reporting notices to come via electronic mail, modernizing communication.



Public Input

- The MHCRC held multiple public meetings and opportunities to submit written comments from October 2024 through January 2025
- Comment 'themes':
 - PEG fee decreasing from 3% down to 2.5% are detrimental to the community media centers
 - Edits are overreaching and go beyond federal cable law(s)



Response to Public Input

- Order 621 imposes requirements that enable cable providers to recover 'marginal' costs for certain costs
- PEG revenues have declines year-over-year due to cable subscribers leaving
 - A 2.5% PEG fee allows Community Media Centers to receive compensation for capital expenses
- The franchise complies with federal cable law and the MHCRC has ensure that the agreement has been reviewed and recommended by legal counsel who specializes in cable law









9-1-1 Call Answering Performance and Average Wait-to-Answer Time Trends 2018 - 2024


