3 approved; and

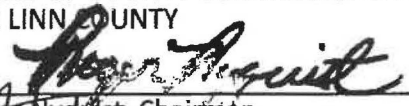

The Road Department has one item on the Board of Commissioners agenda for the weekly meeting on April 9, 2014. The following is a brief description of the item and why we are requesting your approval.

Resolution & Order 2014-020 – Intergovernmental Agreement with the City of Lebanon

This item is an Intergovernmental Agreement with the City of Lebanon to share the development and perform improvements to Cascade Drive, County Road Number 716. The project begins at Wagon Wheel Drive to Crowfoot Road, improvements will include: roadway widening, curbs, sidewalks/multi use path and storm drainage system. After completion of the project, the City of Lebanon will request transfer of jurisdiction for the road.
