Re: Cleaner Air Oregon Submittal 1—Intel Corporation, Gordon Moore Park at Ronler Acres Campus and the Aloha Campus

Dear Julia:

Intel Corporation (Intel) received written notice from the Oregon Department of Environmental Quality (DEQ) on May 29, 2025 that the Gordon Moore Park at Ronler Acres Campus (Ronler) and the Aloha (Aloha) Campuses were being called into the Cleaner Air Oregon (CAO) program. Ronler and Aloha both operate under Standard Air Contaminant Discharge Permit (ACDP) 34-2681-ST-02, issued by the DEQ on April 16, 2024.

Per Oregon Administrative Rule 340-245-0030(1)(a)(A), the first step of the CAO permitting process is to submit an emissions inventory no later than 90 days after receiving the written notice from the DEQ. Intel was granted a partial extension by the DEQ on August 14, 2025, due to the volume of data required for a complete emissions inventory submittal. Intel and DEQ agreed to phased submittals of the emissions inventory and accompanying documents.

The first phase of the emissions inventory submittal, due August 27, 2025, includes the following materials:

- AQ520 form—emissions inventory of natural gas combustion and cooling tower toxic emission units (TEUs), including TEU identifiers (TEU IDs) and descriptors;
- Facility process flow diagrams (PFDs)

The AQ520 form and PFDs were submitted in Your DEQ Online on August 26, 2025.

Intel will schedule a meeting with DEQ to take place no later than September 30, 2025, to discuss a timeline to submit the remaining emissions inventory information. Intel will provide emissions data for the remaining TEUs in the subsequent submittals.

- Ammonia Exhaust (EXAM)
- Emergency Generators (EGEN)
- General Exhaust (EXGF)
- Rotor Concentrator Thermal Oxidizer (RCTO)
- Scrubber Exhaust (EXSC)
- Specialty Exhaust (EXSP)
- Tank (TANK)
- Trimix Waste (TXMW)

- Wastewater Treatment (WWT)
