Microchip Technology Incorporated (Microchip) was called in to the Cleaner Air Oregon (CAO) program on June 30, 2025. On September 9, 2025, DEQ received a request from Microchip for a 90-day extension of the deadline for submittal of the CAO Emissions Inventory (Inventory). DEQ met with Microchip on September 15, 2025, to discuss the reasons for the extension request. Microchip is requesting this extension in order to: 1.) complete review of Safety Data Sheets for the large number of materials used at the facility; 2.) develop and refine the emissions basis for materials and Toxic Air Contaminants that have not been previously reported; 3.) gather vendor information and complete analysis of production data needed in order to estimate a conservative requested Potential to Emit; and 4.) prepare comprehensive documentation for the Inventory. Microchip is proposing to submit a full Inventory no later than December 29, 2025.

DEQ may grant an extension based on the criteria set in [OAR 340-245-0030\(3\)](#), which require sources to demonstrate progress towards completing the submittal and show that a delay is necessary for good cause. Microchip has made progress on the Inventory by engaging Trinity Consultants for technical support and has been developing a draft Inventory over the past year in preparation for Cleaner Air Oregon. The extension is being requested to further refine and verify emissions data and throughputs, and DEQ agrees that a delay is likely to result in a more complete initial Inventory submittal and fewer Inventory revisions.

For these reasons, DEQ approves Microchip's request and grants a 90-day extension from the original submittal deadline of September 29, 2025. Microchip's Inventory must be submitted by no later than **December 29, 2025**.
