On May 29, 2025, Intel Corporation (Intel) received notice that the Gordon Moore Park at Ronler Acres Campus and the Aloha Campus (DEQ Air Quality Source Number 34-2681) were called in to the Cleaner Air Oregon (CAO) program. On August 11, 2025, DEQ received a request from Intel for a partial extension of the deadline for submittal of the CAO Emissions Inventory (Inventory), which DEQ granted on August 14, 2025. DEQ received a partial submittal of the Inventory, including process flow diagrams and emissions information (AQ520 form) for the natural gas combustion units and cooling tower Toxics Emissions Units (TEUs) on August 26, 2025.

As specified in DEQ's approval of Intel's extension request, DEQ met with Intel on September 12, 2025, to discuss the timeline for submittal of the remaining Inventory information. Based on that discussion, and accordance with [Oregon Administrative Rule \(OAR\) 340-245-0030\(1\)&\(3\)](#), Intel must provide the following information by **October 31, 2025**:

1. An Emissions Inventory including all emergency generator and fire pump TEUs, including the AQ520 form and all supplemental documentation required under [OAR-340-245-0040\(4\)](#).
 - a. A separate AQ520 form including only the generators and fire pumps may be used instead of adding to the AQ520 form submitted on August 26, 2025.

Given the complexity of Intel's operations, DEQ plans to continue to review partial Inventory submittals and meet with Intel on a regular basis to provide feedback and discuss due dates for submittal of the remaining required Inventory information and any necessary updates.

DEQ requests that you submit additional information to complete your Inventory. If you think that any of that information is confidential, trade secret or otherwise exempt from disclosure, in whole or in part, you must comply with the requirements in [OAR 340-214-0130](#) to identify this information. This includes clearly marking each page of the writing with a request for exemption from disclosure and stating the specific statutory provision under which you claim exemption. Emissions data is not exempt from disclosure.

DEQ remains available to discuss this information request and answer any questions you may have. Failure to provide additional information, corrections, or updates to DEQ by the deadlines in this letter may result in a violation of [OAR 340-245-0030\(1\)](#).
