Un Ordinance granting unto f. L. Cowaw, Frank O'Weill and L. Foley, their successors and assigns, a right-and franchise to erect, construct and main-tain a system of Water Works in the City of Lebanow, Linu Cs, Oregon -

The People of the City of Lebanow do ordain as follows-

SEO 1 That there be and there is hereby given and granted unto f. L. Cowan, Frank O'Neill and L Foley, Their successors and assigns, The right- and franchise to exect, construct- and maintain in The Streets and alleys of the City of Lebanow, Line Cu. Oregow, all such mains, ditches, pipes, hydrauls and other fixtures as may be neccessary and convenient or usually maintained for the purpose of carrying on a system of Walir Works in said City; and

To construct, Erect and maintain in said Cely all such howers, reservois, buildings, machinery and other fixtures as may be neccessary or convenient or are commonly used for such purpose, Provided, however, That work on the system of Water Works herein mentioned shall be commenced and reasonable progress made Thereon within one year from the approval of this Ordinance by the Wayor of said Cely; and that the aforesaid system of Water Works shall be completed and put-into operation within Eighteen months after the approval of this Ordinance by the Wayor of the City -

This grant is made to said f. L. Cowan, Frank O'Will and L. Foley, Their successors and assigns, for the period of fifteen (15) years from the approval of This Ordinauce by the Mayor whow the Express condition that The said of L' Cowaw, Trank. O'Weill and L' Foley, Their successors and assigns, shall at-all times during said period of fifleen (15) years-after inclion of said system of Water Works, furnish to the Cely of Lebauors, free and without any charge therefor, and as a consideration water for The use of the Council Chamber and the offices for the City Unthorities, together with the necessary pipes, hydrauls and fixtures for the convenient use of said water in said Council Chamber and Cely offices, and a refusal or neglect to furnish said water and fixtures for said Council Chamber or Cely offices, on the fart of f. L. Cowaw, Frank O'Neill and I' Foley, or their successors or assigns, shall immediately make mull and void this grant or franchise and the same shall theseupon revert to the Cely of Lebanow

Their successors or assigns shall erect; construct and reaction all such mains, pipes, ditches, hydrauts and other fixtures in such a manner as will not interfere with the free and unobstructive use of the Struts or alleys of said City for travel, and all such pipes shall be laid at such depth us the City Council may designate

Sec 3 Whenever it-shall become necessary in the construction of any such ditch or the laying of any such
pipe or the exiction of any such hydraul- to interfere
in any manner with any Street-or alley the said
I'L Cowaw, Frank O'Meill and L' Foly, their
successors and assigns, shall without-delay put-such
Structor alley in as good condition as it-was before
broken, dud up or disturbed, and shall at-once remore all surplus earth and rubbish from such
Street-or alley

See 4 The City of Libanow reserves the right to change or modify this Ordinance so as to regulate the charges for the use of the water to be supplied by the said of L Cowau, Frank O'Meill and L Poley, Their successors and assigns, within said City, To be charged by the said grantees—

Sec 5- Within sixly days after the upproval of This Ordinance by the Mayor, The said f. L. Cowan

Frank O'Neill and L' Foley, their successors and assigns shall file with the Recorder of the Oily of Lebanow, their written acceptance thereof and of its provisions—
