AUTHORIZING AN ELECTION ON MAY 20, 1997, IN THE CITY OF
WARRENTON, FOR THE PURPOSE OF VOTING ON A THREE YEAR LEVY
OUTSIDE THE AMOUNT LIMITED BY THE OREGON STATE CONSTITUTION,
TO FUND THE OPERATIONS OF THE CITY OF WARRENTON LIBRARY, FOR THE
FISCAL YEARS 1997-1998 TO 1999-2000, AND DECLARING AN EMERGENCY

Section 1. The Warrenton City Commission resolves as follows:

That an election be held on May 20, 1997, for the purpose of
voting on the following levy, together with ballot title,
submitted directly to the people, as follows:

THREE YEAR LIBRARY OPERATIONS SERIAL LEVY

QUESTION: Shall the City levy \$.06 per \$1,000 assessed value
outside the tax base for library operations for three years?

SUMMARY: The purpose of this serial levy is to fund the
operations for the City of Warrenton library for a period of 3
years. The proposed levy is \$.06 per thousand dollars of
assessed property value, or \$6.00 per year on a \$100,000 house.
The levy would begin July 1, 1997 and end June 30, 2000. The
City will use the money to fund a part-time library site-manager,
purchase books, magazines, reference materials, and to pay for
utilities, maintenance and phone. The library would remain free
for city residents.

This tax is subject to the other governmental purposes limit of
Section 11b, Article XI, of the Oregon Constitution. The money
raised can only be used for library operations.


It is estimated that this serial levy will raise \$10,945 in
FY1997-1998, \$11,274 in FY1998-1999 and \$11,612 in FY 1999-2000.

Section 2. The Warrenton City Manager/Auditor is hereby directed
to give notice of said election, as required by law.

Section 3. The deadline for the May 20, 1997 election is March
20, 1997, and an emergency is hereby declared and this resolution
is effective on its passage.
