Thanks Leela—Glad you asked. I am glad you check!

I am not sure about the rulemaking documents since we moved from Rules to Orders for permit issuance (and back to rule for the 1200-Z) that that shift essentially overruled the rules since they were no longer in effect. I am not sure if there was ever a repeal of the rules, they were just no longer in effect.

Regardless—Diana and Ryan—please remove all of the records listed below for destruction from the items to be destroyed so that can be sorted out. Also, I want to make sure we are not mixing permit types moving forward so we can keep the litigation and rulemaking history with each permit clear and separate.

Thanks Christine, and apologies if this shows my lack of familiarity but I was seeing 1200Z show up in the following lines. Out of abundance of caution just want to triple check these are outside the scope of the litigation.

Also, looking at it more closely, I realized rulemaking documents are a separate retention category on the state general schedule (OAR <u>166-300-0015</u> (1)) and need to be retained until 10 years after the repeal of the entire rule.




