# A RESOLUTION ACCEPTING A RIGHT-OF-WAY DEED FOR THE CH'AK CH'AK TRAIL ABUTTING SE HARLOW ROAD FROM THE OREGON DEPARTMENT OF TRANSPORTATION

#### THE TROUTDALE CITY COUNCIL FINDS AS FOLLOWS:

- 1. The City of Troutdale, ODOT, and other agency partners collaborated to design and construct the 40 Mile Loop: Blue Lake-Sundial & Harlow Road section, located primarily in Troutdale, now known as the Ch'ak Ch'ak Trail.
- 2. The City of Troutdale has agreed to perform ongoing operation and maintenance of the trail within the City limits.
- 3. ODOT provided right of way acquisition services for the project, pursuant to an Intergovernmental Agreement (IGA) with the City of Troutdale and other agency partners, and initially obtained necessary rights of way in ODOT's name.
- 4. Under the terms of the Intergovernmental Agreement, ODOT is to relinquish to the City a 41 square foot trail right of way abutting NE Harlow Road that is needed for ongoing operation and maintenance of the trail.
- 5. The City of Troutdale desires to accept the right of way from ODOT and is obliged to accept the right of way under the terms of the IGA

# NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROUTDALE

Section 1. The City of Troutdale accepts the Relinquishment Deed from the Oregon Department of Transportation included herewith as Attachment A, for trail right of way.

Section 2. This resolution becomes effective upon adoption.

### Relinquishment Deed

In order to complete terms of Misc. Any right-of-way being conveyed in which State has any title shall be vested in City. ONLY SO LONG AS USED FOR PUBLIC ROAD PURPOSES. IF SAID RIGHT OF WAY IS NO LONGER USED FOR PUBLIC ROAD PURPOSES, IT SHALL AUTOMATICALLY REVERT TO STATE. The area being relinquished is described in the legal description and accompanying map, marked Exhibit "A" and Exhibit "B", attached hereto and by this reference made a part hereof.

AS SHOWN ON THE ATTACHED EXHIBIT MAP, HEREIN AND MADE A PART OF THIS DOCUMENT AS SET FORTH ABOVE, THAT IN THE EVENT OF A CONFLICT OR DISCREPANCY BETWEEN THE EXHIBIT MAP AS SHOWN AND THE WRITTEN LEGAL DESCRIPTION EXHIBIT "A", THE WRITTEN LEGAL DESCRIPTION EXHIBIT "A" SHALL PREVAIL.

The property above described is transferred subject to the rights of any utilities located within said property and further subject to the rights of the owners of said existing facilities if any there be, to operate, reconstruct, and maintain their utility facilities presently located within said property.
