1	1. <u>Purpose</u>		
2	This Consent Judgment is filed simultaneously with and for the purpose of		
3	resolving the underlying complaint by the State of Oregon. Plaintiff State of Oregon ex rel.		
4	the Director of the Department of Environmental Quality ("DEQ") and Defendant Arcadia		
5	Paper Mills, LLC ("Defendant") (collectively, the "Parties") desire to resolve this action		
6	without litigation and have agreed to entry of the Consent Judgment without admission or		
7	adjudication of any issue of fact or law. The mutual objectives of the Parties are: (a) to		
8	protect public health, safety, and welfare and the environment in accordance with		
9	ORS 465.200 through 465.410, and regulations promulgated thereto, and (b) to facilitate		
10	productive reuse of property; and (c) to provide Defendant with protection from potential		
11	liabilities in accordance with applicable law.		
12	2. <u>Stipulations and Findings</u>		
13	A. Defendant stipulates:		
14	(1) To entry of this Consent Judgment;		
15	(2) To perform and comply with all provisions of this Consent Judgment; and		
16	(3) To not litigate, in any proceeding brought by DEQ to enforce this		
17	Consent Judgment or to assess penalties for noncompliance with this Consent Judgment, any		
18	issue other than Defendant's compliance with this Consent Judgment.		
19	B. DEQ and Defendant stipulate:		
20	(1) For the purposes of this Consent Judgment, the "Facility", as defined in		
21	ORS 465.200(13), means: (a) the Property; and (b) the full extent of existing known or		
22	unknown contamination by hazardous substances of any media on, above, or below the		
23	Property, or that has migrated, might have migrated, or hereafter migrates to anywhere from		
24	the Property.		
25	(2) For the purposes of this Consent Judgment, "Matters Addressed" means		

all investigation, removal, and remedial actions taken or to be taken and all remedial action

1	costs incurred or to be incurred at or in connection with a release of hazardous substances at
2	the Facility.
3	(3) For the purposes of this Consent Judgment, "Existing Hazardous Substance
4	Releases" means: (a) any release of hazardous substances, as defined in ORS 465.200, at the
5	Facility existing as of the date of Defendant's acquisition of ownership or operation of the
6	Property; (b) any spill or release of oil or hazardous material, as defined in ORS 466.605, at the
7	Facility existing as of the date of Defendant's acquisition of ownership or operation of the
8	Property; and (c) the entry of oil into the waters of the state, as defined in ORS 468B.300, from
9	the Facility before the date of Defendant's acquisition of ownership or operation of the Property.
10	C. DEQ finds, and Defendant neither admits nor denies:
11	(1) Arcadia Paper Mills, LLC is an Oregon limited liability company with its
12	principal place of business at 11101 Etiwanda Avenue, Fontana, California 92337.
13	(2) The property proposed for acquisition by Defendant, currently owned by the
14	City of St. Helens, a municipal corporation of the State of Oregon, is an approximately 30-acre
15	site located at 1300 Kaster Road, St. Helens, Columbia County, Oregon, in Section 9, Township
16	4 North, Range 1 West, of the Willamette Meridian (the "Property"). The location of the
17	Property is illustrated generally in the Vicinity Map, Exhibit A to this Consent Judgment. The
18	legal description of the Property is set forth in Exhibit B to this Consent Judgment. All
19	attachments are incorporated into this Consent Judgment by this reference.
20	(3) The Property has been occupied by a pulp and paper manufacturing facility
21	with rail spur since the 1920s, which has included the storage and use of hazardous substances
22	and petroleum products including aboveground storage tanks, underground storage tanks, and
23	equipment containing polychlorinated biphenyls (PCBs). According to historical site documents
24	a bleach plant was constructed on the Property in 1955, and a second bleach plant was
25	constructed in the mid-1960s. Pulp production consisted of the kraft chlorine bleaching process
26	until its phase-out in the 1990s, when a chlorine dioxide generation plant was constructed. Use

1	of elemental chlorine was completely phased out of the bleaching sequence		
2	in 2001. The Property has been unoccupied since 2023 when the last tenant of the mill vacated		
3	the facility. The Property was historically included in a larger 285-acre facility; however, only		
4	roughly 30 acres of the facility are being purchased for use of the existing facility and related		
5	industrial development.		
6	(4) Several spills and/or hazardous material incidents have been reported for the		
7	Property. Releases include various amounts of oils, white liquor, fuels, sodium hypochlorite, and		
8	sulfuric acid to soil, pavement, concrete, and/or surface water. Additionally, dredged sediment		
9	fill has been reported to be located under the railroad lines and potentially in other areas of the		
10	mill facility. The source of the fill material is unknown and there is a potential that the fill		
11	material may contain hazardous substances and/or petroleum products as sediment from the		
12	Multnomah Channel/Scappoose Bay is being assessed for constituents of concern including		
13	PAHs, dioxins/furans, PCBs, and metals. Impacts identified through a focused environmental		
14	investigation are indicative of historical use of the Property demonstrating that hazardous		
15	substances have been released to soil and/or groundwater and include but may not be limited to		
16	the following:		
17	Oil-range petroleum hydrocarbons		
18	• Arsenic		
19	• Lead		
20	• PCBs		
21	 Pentachlorophenol

24	These contaminants are "hazardous substances" within the meaning of ORS 465.200(16). The		
25	presence of hazardous substances at the Property constitutes a "release" of hazardous substances		
26			

1	within the meaning of ORS 465.200(22) and makes the Property a "facility" within the meaning		
2	of ORS 465.200(13).		
3	(5) Pursuant to ORS 465.255(1)(b), Defendant could become liable to DEQ and		
4	other persons for releases of hazardous substances at or from the Property by becoming the		
5	owner or operator of the Property with actual or constructive knowledge of the releases. On		
6	November 25, 2024, Defendant applied to DEQ for a "prospective purchaser" agreement under		
7	ORS 465.327 and agreed to reimburse DEQ's costs of technical review and preparation. This		
8	Consent Judgment is intended to protect Defendant from potential liability for pre-acquisition		
9	releases of hazardous substances at or from the Property, in return for Defendant undertaking		
10	certain obligations, as described in this Consent Judgment. In determining to propose this		
11	Consent Judgment, DEQ considered reasonably anticipated future land uses at the Property and		
12	surrounding properties and consulted with the City of St. Helens and Columbia County. This		
13	Consent Judgment is entered into pursuant to ORS 465.325 and ORS 465.327.		
14	(6) On June 1, 2025, DEQ published notice of this proposed Consent Judgment		
15	and provided opportunity for public comment in accordance with ORS 465.320(1) and		
16	465.325(4)(d). The comment period ended July 6, 2025. Comments were received and		
17	considered by DEQ, as documented in the administrative record.		
18	(7) Consistent with ORS 465.327(1):		
19	(a) Defendant is a "person" within the meaning of ORS 465.200(21);		
20	(b) Defendant is not currently liable under ORS 465.255, 466.640, or		
21	468B.310 for the Existing Hazardous Substance Releases;		
22	(c) Removal or remedial action is necessary at the Property to protect		
23	human health or the environment;		
24	(d) Defendant's ownership and operation of the Property will not cause,		
25	contribute to, or exacerbate existing contamination, increase health risks, or interfere with		
26	remedial measures at the Property; and

1	(e) A substantial public benefit will result from this Consent Judgment.
2	(8) Based on the administrative record, the Director of DEQ determines that:
3	(a) the release from liability set forth in Subsection 5.B satisfies the criteria set forth in
4	ORS 465.327(1); (b) the covenant not to sue set forth in Subsection 5.D satisfies the criteria set
5	forth in ORS 465.325(7)(a) and (d); and (c) this Consent Judgment and Defendant's
6	commitments under this Consent Judgment will expedite removal or remedial action, minimize
7	litigation, be consistent with rules adopted under ORS 465.400, and be in the public interest.
8	3. Work to be Performed
9	A. Remedial Design and Remedial Action
10	Defendant will perform the remedial design and remedial action for the Site in
11	accordance with the terms and schedules set forth in the Scope of Work ("SOW") attached to and
12	incorporated by reference into this Consent Judgment as Exhibit C, and the terms and schedules
13	set forth in a DEQ-approved work plan.
14	B. Modification of SOW or Related Work Plans
15	(1) If DEQ determines that modification to the work specified in the SOW
16	and/or in work plans developed pursuant to the SOW is necessary in order to implement or
17	maintain the effectiveness of the remedy set forth in the ROD, DEQ may require that such
18	modification be incorporated in the SOW and/or such work plans; provided, any such
19	modification may be required pursuant to this paragraph only to the extent that the modification
20	is consistent with the scope of the remedy selected in the ROD.
21	(2) Subject to dispute resolution under Subsection 7.M., Defendant will
22	modify the SOW and/or work plans as required by DEQ and implement any work required by
23	the modifications. Before invoking dispute resolution under Subsection 7.M., Defendant and
24	DEQ will make a good-faith effort to resolve any dispute regarding DEQ-requested
25	modifications by informal discussions for no more than 30 days following notice from DEQ
26	of a requested modification.

- 2 Defendant may elect at any time during the term of this Consent Judgment to

- 5 Property. Such additional measures are subject to prior approval by DEQ. DEQ's approval
- 6 will be granted if DEQ determines that the additional measures are consistent with the
- 7 remedial action objectives in the ROD and will not threaten human health or the
- 8 environment.

D. Site Restrictions and Periodic Reviews

- 10 (1) Within six months of entry of this Consent Judgment, Defendant will
- 11 record with the County Clerk, Columbia County, an Easement and Equitable Servitude in
- such form as to be agreed upon by DEQ and Defendant. Defendant will provide DEQ a file-
- 13 stamped copy of the Easement and Equitable Servitude within five working days of
- 14 recording.
- 15 (2) Property subject to the Easement and Equitable Servitude may be freely
- alienated at any time after recording, provided the deed or other instrument of conveyance
- 17 refers to or incorporates the Easement and Equitable Servitude.
- 18 (3) Any deed, title, or other instrument of conveyance regarding the Property
- 19 must contain a notice that the Property is the subject of this Consent Judgment. Defendant,
- 20 in any such deed or conveyance, must also reserve such access (by easement, right-of-way,
- 21 or otherwise) as might be necessary to carry out Defendant's obligations under this Consent
- 22 Judgment.
- 23 (4) At least once every five years, DEQ will review the remedy to ensure that
- 24 the Property remains protective of public health, safety, and welfare and the environment.
- 25 Periodic reviews will include evaluation of monitoring data, progress reports, inspection and
- 26 maintenance reports, land and water uses, compliance with institutional controls, and any

12	extends the time for completion by Defendant. Prior approval is not required in
13	emergencies, provided Defendant notifies DEQ immediately after the emergency and
14	evaluates the impact of its actions.
15	(2) After review of any plan, report, or other item required to be submitted
16	for DEQ approval under this Consent Judgment, DEQ will: (a) approve the submission in
17	whole or in part; or (b) disapprove the submission in whole or in part, and notify Defendant
18	of its deficiencies and/or request modifications to cure the deficiencies.
19	(3) DEQ approvals, rejections, or identification of deficiencies will be given
20	in writing within the time specified in the SOW or as soon as practicable, and will state
21	DEQ's reasons with reasonable specificity.
22	(4) In the event of DEQ disapproval or request for modification of a submission
23	Defendant will, within 30 days of receipt of the DEQ notice or such longer time as may be
24	specified in the notice, either correct the deficiencies and resubmit the revised report or other
25	item for approval, or invoke dispute resolution under Subsection 4.M.
26	(5) In the event of two deficient submittals of the same deliverable that are

10	relating to work under this Consent Judgment; conducting such tests and taking such samples as	
11	DEQ deems necessary, verifying data submitted to DEQ by Defendant; conducting periodic	
12	review; and using camera, sound recording, or other recording equipment. DEQ will make	
13	available to Defendant, upon Defendant's request, any photographs or recorded or videotaped	
14	material taken.	
15	(2) Defendant will seek to obtain access to property not owned or controlled by	
16	Defendant as necessary to perform the work required in this Consent Judgment, including access	
17	by DEQ for purposes described in Paragraph 4.D.(1). DEQ may use its statutory authority to	
18	obtain access to property on behalf of Defendant if DEQ determines that access is necessary and	
19	that Defendant has exhausted all good faith efforts to obtain access.	
20	E. Records	
21	(1) In addition to those reports and documents specifically required under this	
22	Consent Judgment, Defendant will provide to DEQ, within 10 days of DEQ's written	
23	request, copies of Quality Assurance/Quality Control (QA/QC) memoranda and audits, raw	
24	data, final plans, task memoranda, field notes (not made by or at the direction of Defendant's	
25	attorney), and laboratory analytical reports relating to the work to be performed under this	
26	Consent Judgment.

14	at the time the documents or records are submitted to or copied by DEQ, the documents or	
15	records may be made available to the public without notice to Defendant.	
16	(4) Defendant will identify to DEQ (by addressor-addressee, date, general	
17	subject matter, and distribution) any document, record, or item withheld from DEQ on the	
18	basis of attorney-client or attorney work product privilege, except to the extent that such	
19	identifying information is itself subject to a privilege. Attorney-client or work product	
20	privilege may not be asserted with respect to any records required to be submitted under	
21	Paragraph 4.E.(1). DEQ reserves its rights under law to obtain documents DEQ asserts are	
22	improperly withheld by Defendant.	
23	F. Notice and Samples	
24	(1) Defendant will make every reasonable effort to notify DEQ of any	
25	excavation, drilling, sampling, or other fieldwork to be conducted under this Consent	
26	Judgment at least five working days before such activity, but in no event less than 24 hours
