Requested Updates to Report:

- 1. **Section 3.1.1**: For documentation purposes, include a note with the second bulleted item that the AQ521 and AQ522 exposure location variance forms were included with the first Modeling Protocol and Risk Assessment Work Plan submittal on February 26, 2025.
- 2. **Table 3-1**: Include REER units (g/s per µg/m³).
- 3. **Table 4-1**: The following chronic noncancer risks are shown as "<0.1" in the table, but should round to "0.1" following the rounding rules in OAR 340-245-0200(4):
 - a. Residential chronic noncancer risk; and
 - b. Nonresidential work chronic noncancer risk.
- 4. **Section 4.1**: Include mention of annual verification of land use changes since ADS has requested changes to exposure locations.

Requested Updates to Appendices:

- 5. **Appendix C**: Update table names in Appendix C to reflect appropriate Appendix number. Currently formatted as "Table Dx.x".
- 6. Appendix E:
 - a. Update table names in Appendix E to reflect appropriate Appendix number. Currently formatted as "Table Fx.x".
 - b. Include REER units (g/s per µg/m³) in the Screening REER tables.
- 7. Appendix G:
 - Update table name to reflect appropriate Appendix number. Currently formatted as "Table H-5".
 - b. Correct rounding errors for the following:
 - i. Residential chronic noncancer risk rounds to 0.1; and

ii. Nonresidential work chronic noncancer risk rounds to 0.1.
