# Purpose and Importance

**Annual Adjustment:** EQC may increase water quality fees by up to 3% annually (ORS 468.051(2))

**Recalibration:** Policy option package 120 approved by the 2025 Legislature authorized the EQC to increase fees by more than 3% for:

- Underground Injection Control
- 401 Dredge and Fill Certification
- Onsite Wastewater Management
- Wastewater Operator Certification

**The fee increases maintain current service levels for water quality permitting, licensing, certification and groundwater protection services.**

# Prior EQC Involvement

# Fee Increases: Water Quality Programs

---

## WATER QUALITY PERMITTING

- Sustained by 89 full time employees
- The program develops and implements:
  - ~ 300 NPDES Individual permits
  - ~ 200 WPCF Individual permits
  - ~ 1000 General permit registrants
  - ~ 2000 Stormwater permits
- Has increased fees annually by 3% for the last several years

**Maintains, enhances and protects Oregon's waters by regulating pollutant discharge through the permitting process**

# Fee Increases: Water Quality Programs

---

## UNDERGROUND INJECTION CONTROL (UIC)

- Sustained by 2.4 full time employees
- Oversight of 40,000+ registered UICs, hundreds added each year
- Addresses and resolves concerns raised by the public
- Assists consultants with rules and policies
- Supports municipalities, businesses and residents statewide

**Protects drinking  
water aquifers from  
contamination**

Proposed increase:  
 $3\% + 15\% = 18\%$

# Fee Increases: Water Quality Programs

## 401 WATER QUALITY CERTIFICATION

- Sustained by 4.0 full time employees
- Issues certifications to federal and state agencies, municipalities, businesses and residencies
- Reviews ~200 application requests per year
- Inspects certified project sites and responds to complaints

**Issues state water quality certifications for projects requiring a federal license or permit to work in surface waters of the U.S.**

Proposed  
increase:  
 $3\% + 20\% = 23\%$

# Fee Increases: Water Quality Programs

---

## ONSITE WASTEWATER MANAGEMENT

- Sustained by 12 full time employees
- Processes 850+ applications each year
- Program implementation in three counties
- Oversight and technical assistance across 33 counties
- Licenses sewage disposal services, manages septic permitting, provides product approvals and training

**Siting, installation and operation of residential and small commercial septic systems**

Proposed  
increase:  
 $3\% + 30\% = 33\%$

# Fee Increases: Water Quality Programs

## WASTEWATER OPERATOR CERTIFICATION

- Sustained by 2.3 full time employees
- Oversight ~400 public and private wastewater systems and ~1400 certified operators
- Coordinates with Oregon Health Authority
- Supports education, application and renewal processing, evaluating course curricula for CEUs

*The proposed rulemaking also includes a minor clarification related to exam scoring.*

**Ensures wastewater operators safely operate domestic sewage wastewater systems**

Proposed increase:  
 $3\% + 14\% = 17\%$  2026  
12% 2027

Operator Certification – Renewal fee Grade II certificates, per person	\$168	3% + 17%	\$201	\$33
1200-U UIC General Permit – Annual fee City with 14 medium risk, and 4 high risk UICs	\$1,492	3%	\$1,534	\$42
401 WQC Wetland impact fee	\$1,044	3% + 20%	\$1,284	\$240
Stormwater	\$1,558	3%	\$1,604	\$46
<b>Total increase</b>	<b>\$15,339</b>		<b>\$16,097</b>	<b>\$758</b>

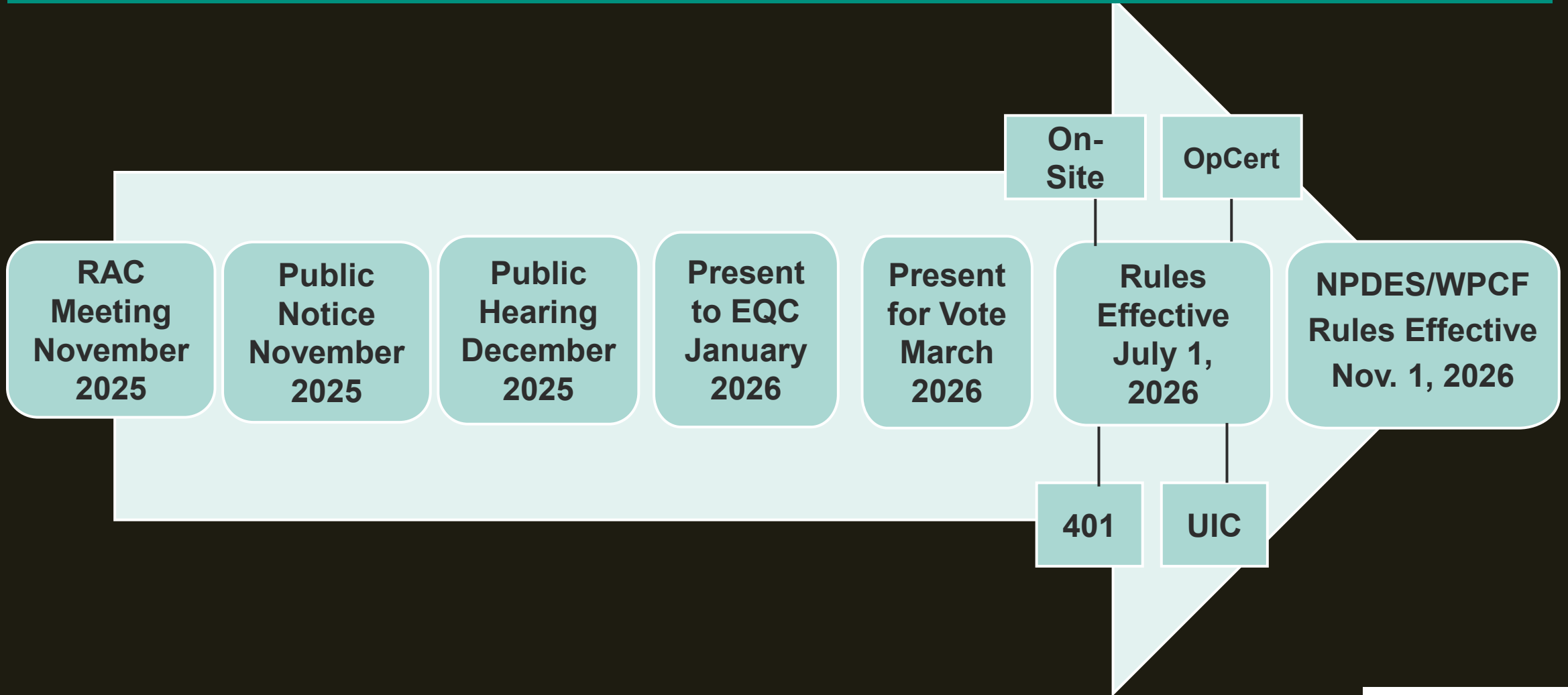
# Key Issues: Onsite Septic System Example

New residential onsite septic system in a direct service county*	Current DEQ fees	Proposed fee	Increase
Site Evaluation application + administrative surcharge	\$963	\$1,280	\$317
Type D Permit application + administrative surcharge	\$1,652	\$2,196	\$544
Total	\$2,615	\$3,476	\$861

The other 33 counties are managed by local governments.

\* The direct service counties are Curry, Jackson, and Josephine counties.

# Closing: Key Takeaways

---

## WATER QUALITY ANNUAL FEE INCREASE AND POP120 RECALIBRATION:

- Maintains current service levels across water quality programs
- Annual increase uses statutory authority for modest, predictable future increases
- Recalibration addresses long-standing fee gaps
- Supports timely permitting, certification and groundwater protection
