On May 29, 2025, Intel Corporation (Intel) received notice that the Gordon Moore Park at Ronler Acres Campus and the Aloha Campus (DEQ Air Quality Source Number 34-2681) were called in to the Cleaner Air Oregon (CAO) program (Your DEQ Online [YDO] submittal #68522). Given the complexity of Intel's operations, DEQ is reviewing partial Inventory submittals and meeting with Intel on a regular basis to provide feedback. On December 31, 2025, Intel submitted a request to DEQ for a 32-day extension of the deadline for partial Emissions Inventory Submittal #3, the Emissions Inventory for Tanks and Exempt TEU Emissions. As specified in DEQ's November 14, 2025 due date notification letter, this submittal must include following information:

1. An Emissions Inventory including an AQ520 form and all supplemental documentation required under [OAR-340-245-0040\(4\)](#) for all storage tanks on site that emit Toxic Air Contaminants (TACs) or store materials containing TACs;
2. A [Categorically Exempt Toxics Emissions Units \(AQ523\) form](#) listing TEUs that are exempt under [OAR 340-245-0060\(3\)\(b\)](#); and
3. A list of any TEUs that Intel is requesting exemption for under [OAR 340-245-0060\(3\)\(a\)](#) recorded on Worksheet 2 of the AQ520 form and accompanied by sufficient documentation to demonstrate that the TEU is not likely to materially contribute risk.

Intel is requesting the extension in order to verify the large amounts of chemical data gathered and used in the emissions calculations and to work with the developer of the emissions software to validate the emissions calculations.

DEQ may grant an extension based on the criteria set in [OAR 340-245-0030\(3\)](#), which require sources to demonstrate progress towards completing the submittal and show that a delay is necessary for good cause. Intel has demonstrated progress on the submittal by compiling chemical and waste characterization data for toxic air contaminants, updating chemical parameters in their tank emissions model, and determining specific pollutant abatement parameters. DEQ agrees that a delay may be necessary in order to verify, validate, and document the large amount of data and calculations used to determine emissions.

For these reasons, DEQ approves Intel's request and grants a 32-day extension from the original submittal deadline of January 16, 2026 for Intel's Emissions Inventory for Tanks and Exempt TEU Emissions (Emissions Inventory Submittal #3). The information listed in Items 1-3 above must be submitted by no later than **February 17, 2026**. This approval does not modify any other submittal deadlines.
