Biomass One, L.P. (Biomass One) was called in to the Cleaner Air Oregon (CAO) program on April 26, 2024. Biomass One submitted a CAO Emissions Inventory (Inventory) on December 20, 2024. In accordance with Oregon Administrative Rule ([OAR 340-245-0030\(2\)](#)), DEQ issued a written request on July 25, 2025, requiring additional information and a revised Inventory to be submitted by September 8, 2025. Biomass One requested and was granted a partial extension on this deadline and submitted responses to DEQ's July 25, 2025, request on September 5, 2025, and October 6, 2025. DEQ reviewed the Inventory and sent a Comment Letter on December 19, 2025, requesting additional revisions to the Inventory to be submitted by February 2, 2026. On January 14, 2026, DEQ received a request from Biomass One for a 60-day extension to submit the Inventory (Your DEQ Online Submittal ID71148) by no later than April 3, 2026.

DEQ may grant an extension based on the criteria set in [OAR 340-245-0030\(3\)](#), which require sources to demonstrate progress towards completing the submittal and show that a delay is necessary for good cause. DEQ understands that Biomass One is operating with severely limited environmental compliance personnel capacity due to circumstances outside of Biomass One's control. DEQ agrees that an extension would allow Biomass One the time necessary to better address all DEQ's comments.

For these reasons, DEQ approves Biomass One's request and grants a 60-day extension from the original submittal deadline of February 2, 2026. Biomass One's Inventory must be submitted by no later than **April 3, 2026**.
