



RESOLUTION NO. 2026-05-20-16

**APPROVING A TEMPORARY FARE REDUCTION
FOR LANE TRANSIT DISTRICT SERVICES
EFFECTIVE JULY 1, 2026, THROUGH AUGUST 31, 2026**

WHEREAS, Lane Transit District ("District") is authorized under ORS 267.320 to establish, regulate, and collect fares for the use of District transportation services; and

WHEREAS, District Ordinance No. 53 establishes the District's fare structure and policies for the use of District services; and

WHEREAS, Section 1.02(4) of District Ordinance No. 53 authorizes the General Manager, or designee, to reduce or eliminate transit fares upon a finding that such fare reduction or elimination will promote increased use of the District's public transit system or otherwise further the provision of public transit service; and

WHEREAS, the Chief Executive Officer duly provided supporting analysis regarding projected ridership impacts and fare elasticity assumptions evidencing that the accompanying temporary fare reduction authorized by this Resolution will promote increased ridership, encourage use of District services, and further the District's public transit mission; and

WHEREAS, the District Board of Directors has reviewed and hereby approves the findings of the Chief Executive Officer that the temporary fare reduction authorized by this Resolution will promote increased ridership, encourage use of District services, and further the District's public transit mission; and

WHEREAS, the District Board of Directors further finds that the promotional fare reduction authorized by this Resolution is temporary and administrative in nature, lasting less than six months, and does not permanently amend the District's fare structure; and

WHEREAS, upon expiration of the promotional temporary fare reduction authorized herein, the fares established by Ordinance No. 53 shall automatically resume unless otherwise modified by future Board action;


NOW, THEREFORE, BE IT RESOLVED by the Lane Transit District Board of Directors that:

1. Effective July 1, 2026, through August 31, 2026, the temporary reduction of fares for Lane Transit District services shall be as set forth in Exhibit A attached hereto and incorporated herein by this reference.
2. Except as expressly modified by this Resolution for the limited time period stated herein, all other provisions of Ordinance No. 53 shall remain in full force and effect.
3. At 12:00 AM PST on September 1, 2026, the temporary fare established by this Resolution shall automatically expire and the fares established under Ordinance No. 53 shall resume without further Board action.



4. The Chief Executive Officer or his/her designee is authorized to take all actions necessary to implement this temporary fare adjustment.
