## City of Sherwood, Oregon Resolution No. 93-556

A RESOLUTION DECLARING SURPLUS MATERIALS TO BE SOLD AT PUBLIC AUCTION OR OTHERWISE DISPOSED OF, AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City has surplus materials, supplies and property which are no longer needed for City operations, which items are more particularly described on "Exhibit A" attached hereto, item numbers 1 through 23 being abandoned property in the possession of the City, and items number 31 through 34 and 41 through 45 being surplus City property; and

WHEREAS, an auction of surplus government property will be held at a time and location to be determined by City staff at a future date.

NOW, THEREFORE, THE CITY RESOLVES AS FOLLOWS:

Section 1. Surplus: That items 1 through 23, 31 through 34, and 41 through 45, as described on "Exhibit A" are declared surplus.

Section 2. Disposal: That the items numbered 1 through 23, 31 through 34 and 41 through 45 are declared no longer necessary and useful for City operations and purposes and shall be immediately sold or disposed of.

Section 3. Auction: That it is hereby ordered that the items described in Section 2 be offered for sale at public auction to the highest bidder, said auction be held in accordance with applicable City ordinances.

Section 4. Other Means of Disposal: If not sold at auction, the items in Section 2 shall be disposed of or destroyed in accordance with applicable City ordinances.

<u>Section 5. Effective Date:</u> That this Resolution shall be effective upon its approval and adoption.
