Approving a \$0.31 three year tax rate serial levy



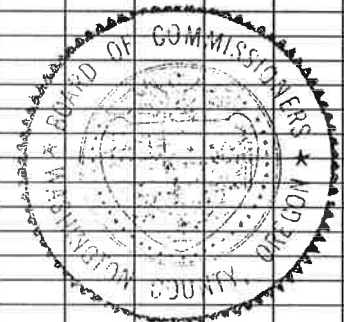
