RESOLUTION

WHEREAS, heretofore on the 6th day of August, 1955, CLYDE SANDERS and CLARA SANDERS, husband and wife, made, executed and recorded a certain agreement with the CITY OF SHERWOOD, OREGON, in the form of a mortgage to secure the payment to said city of the sum of \$200.00 for each of certain tracts of land in said agreement described, said agreement being recorded on the 12th day of September, 1955, in Book 336 at page 55, Mortgages of Washington County, Oregon; and

(b) That the Mayor and Recorder are hereby authorized to cause to have said lien on the above herein described property discharged of public record aby affixing their signatures to a copy

of the within resolution and certifying same to be a true copy of the resolution passed by unanimous vote of the City Council of the City of Sherwood, Oregon, at its regular meeting held in the City Hall on the 7th day of November, 1955, and by duly acknowledging their signatures before a notary public.
