

From minutes of September 2, 1960

A prepared Resolution authorizing and directing a hearing shall be held before the Council in the City Hall at Sherwood, Oregon at 7:30 o'clock P. M. on Monday the 12th day of September, 1960 for the purpose of affording all persons particularly interested and the general public an opportunity to be heard relative to the aforesaid naming and renaming of streets in said City as recommended by the said Planning Commission.

That the Recorder of said City of Sherwood be and he hereby is, directed to publish a Notice of said Hearing, stating the time and place thereof, and the nature and purpose of said Hearing generally, Said Notice shall be published in the Tri-City News, not less than once within the week prior to the week within which the above described Hearing will be held. A motion was made by councilman Moore, seconded by Cochran and passed

by vote of the council that such Resolution be adopted. The Publisher of the Tri City News was handed a copy for publication as stated in said Resolution.

A Resolution was read to the Council pertaining to a certain street in said City of Sherwood named SOUTH SHERWOOD BOULEVARD and the Southerly continuation thereof is bounded and described in an unsatisfactory manner, and the property lines thereof are confused and complicated in such a way as to interfere with the orderly development and growth of said City; and WHEREAS, it is necessary and desirable that a new plat and survey of Said SOUTH SHERWOOD BOULEVARD and the continuation thereof, should be prepared, approved and submitted to the Council and to the property owners adjacent to said Street for the PURPOSE OF CORRECTING AND MAKING UNIFORM THE PROPERTY LINES and boundaries of said SOUTH SHERWOOD BOULEVARD, and the continuation thereof; and THE COUNCIL BEING NOW FULLY ADVISED IN THE PREMISES.

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Sherwood, Oregon as follows: to-wit:

That the Council has and does hereby appoint and designate Hal P Barrows, County Surveyor of Washington County Oregon to serve in lieu of a City Engineer for the purpose of approving any plat, survey or dedication relative to SOUTH SHERWOOD BOULEVARD and the continuation thereof in said City of Sherwood, Oregon.

RESOLUTION

WHEREAS, the Council of the City of Sherwood, Oregon has investigated and determined that a certain street in said City named SOUTH SHERWOOD BOULEVARD and the Southerly continuation thereof is bounded and described in an unsatisfactory manner, and the property lines thereof are confused and complicated in such a way as to interfere with the orderly development and growth of said City; and

WHEREAS, the City of Sherwood has no City Engineer or other official authorized to approve plats and dedications within said City; and

WHEREAS, it is necessary and desirable that a new plat and survey of said SOUTH SHERWOOD BOULEVARD and the continuation thereof, should be prepared, approved and submitted to the Council and to the property owners adjacent to said street for the purpose of correcting and making uniform the property lines and boundaries of said SOUTH SHERWOOD BOULEVARD and the continuation thereof; and

THE COUNCIL BEING NOW FULLY ADVISED IN THE PREMISES.

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Sherwood, Oregon as follows, to-wit:

1. That the Council has and does hereby appoint and designate Hal P. Barrows, County Surveyor of Washington County, Oregon to serve in lieu of a City Engineer for the purpose of approving any plat, survey or dedication relative to SOUTH SHERWOOD BOULEVARD and the continuation thereof in said City of Sherwood, Oregon.
