

R E S O L U T I O N

WHEREAS, THE COMMON COUNCIL OF THE CITY OF SHERWOOD, OREGON, at a special meeting held at the City Hall on April 18, 1963, at 8 o'clock p. m., seriously considered a letter from the State Sanitary Authority which advised the City Council that its request for additional ^{time} which to comply with certain instructions by July 1, 1963, was denied, and;

WHEREAS, the Council's ability to comply with the State Sanitary Authority's instructions by July 1, 1963, depends upon the financial support each of the two major industries in Sherwood agrees to provide to carry out, substantially, the program set forth in the Stevens-Thompson sewer treatment report, and;

WHEREAS, no written assurance has been received by the City from the two industries, (The Portland Canning Company and The Frontier Leather Company), as to whether or not they intend to participate in this program, nor to what extent, if any;

NOW, THEREFORE, BE IT AND IT HEREBY IS RESOLVED, as follows:

That, in view of the City's responsibility to the State Sanitary Authority for the pollution of Cedar Creek, the Council hereby direct Attorney Fred Anderson to advise each of the above mentioned industries that the City cannot defer action toward meeting the demands of the State Sanitary Authority. That the City must immediately pursue a program to meet such demands even tho any of the industries do not wish to participate. That plans must be made for the construction and financing of sewer facilities adequate to meet the needs of the domestic sewage and of any other participants.

That, each industry be required to present to the Council, in writing, on or before May 3, 1963, whether it will participate in the program and on what terms, and unless a written statement is received by the City on or before the Council meeting, May 3, 1963, it will be assumed by the city that such industry declines to participate and intends to assume responsibility for the entire disposal of its wastes.
