## CITY OF SHERWOOD, OREGON

RESOLUTION OF CITY COUNCIL ADOPTING THE BUDGET OF THE CITY OF SHERWOOD FOR THE YEAR BEGINNING JULY 1, 1969, AND ENDING JUNE 30, 1970, MAKING APPROPRIATIONS IN ACCORDANCE WITH THE BUDGET DOCUMENT, DECLARING A TAX LEVY AND CERTIFYING THE AMOUNT OF TOTAL TAXES TO BE LEVIED FOR ALL FUNDS AS SHOWN BY THE BUDGET.

WHEREAS, the Budget for the City of Sherwood for the year beginning July 1, 1969, and ending June 30,1970, was duly approved by the duly constituted Budget Committee at its meeting of April 24, 1969, after proceedings in accordance with Chapter 294 O.R.S.

WHEREAS, a hearing by the City Council on the budget document as approved by the Budget Committee, was duly called to be held on the 16th day of May, 1969, for the purpose of affording any person an opportunity to appear and be heard for or against any item in the Budget; and

WHEREAS, a summary of the Budget document as required by §294.416 O.R.S. was duly published in the Tri-City Times in accordance with §294.421 O.R.S. prior to the date of said hearing on May 16, 1969; and

WHEREAS, the said hearing was duly and regularly held by the City Council at its special meeting of May 16, 1969; and

WHEREAS, at the special election duly and regularly held within the City of Sherwood on May 19, 1969, there was submitted to the legal voters of the City the question of whether or not to approve the proposed budget; the results of said election having been duly filed and canvassed, and the legal voters of the City having duly adopted the budget by a majority vote of all registered voters voting at said election; and

WHEREAS, it appears that all conditions precedent to adoption of the Budget, the making of appropriations, declaring a tax levy for each fund and certifying the tax levy, have been duly and regularly conducted in accordance with Chapter 294, O.R.S., AND THE CITY COUNCIL SO FINDS;

## NOW, THEREFORE, IT IS HEREBY RESOLVED as follows:

- (1) That the Budget for the year beginning July 1,1969, and ending June 30,1970, as heretofore adopted by the Budget Committee and as duly published and heard, a copy whereof being hereto attached and by reference made a part hereof, be, and the same is hereby adopted.
- (2) That the appropriations shown by said Budget for each fund, and the levy therein set forth with respect to each fund, be, and the same are hereby appropriated, determined and declared as a tax levy for each such fund.
- (3) That the total taxes to be certified for levy for all funds in accordance with said Budget in the sum of \$43,870 be, and the same are hereby determined, declared and certified by the City of Sherwood for the year beginning July 1, 1969, and ending June 30,1970.
- (4) That the Mayor and City Recorder be, and they are, respectively authorized and directed to certify the levy to the Department of Revenue and Taxation of Washington County, Oregon.
