RESOLUTION 225

A Resolution furthering annexation to the City of Sherwood of the territory described in Exhibit "A" attached.

WHEREAS "consents" in the form of a petition have been presented to the City of Sherwood requesting annexation of certain tracts of land presently contiguous to the corporate limits of the City; and

WHEREAS the consents in the form of a petition were signed by the owners of said tracts of land; and

WHEREAS, the City of Sherwood Council has reviewed the consents and set the final boundary for the annexation as required by ORS 199.490(2); and

WHEREAS, subsequent to the setting of the final boundary the consents for land contained therein represent "more than half of the owners of land in the territory, who also own more than half of the land in the contiguous territory and of real property therein representing more than half of the assessed value of all real property in the contiguous territory;" and

WHEREAS, the proposed annexation therefore is in accordance with ORS 199.490(2) and constitutes a so-called "triple majority" annexation and a "minor boundary change" under boundary commission law, ORS 199.410 to 199.510.

NOW THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF Sherwood, a municipal corporation of the State of Oregon, at a regular session held on the 9th day of December 1981, that:

<u>Section 1</u>. The Council hereby approved the proposed annexation and requests the Commission to approve it and effect it as soon as possible.

<u>Section 2</u>. The City Recorder is hereby directed to file certified copies of the statements of consent and of the Resolution with the Portland Metropolitan Area Local Government Boundary Commission at once.

Tonquin Road, County Road No. 2257; Thence along said Westerly line: along the arc of a 497.46 Foot radius curve (radius point bears Northeasterly) through a central angle of 12°06'52", 105.18 Feet (chord Bears North 30°18'26" West, 104.99 Feet); Thence North 24°15' West, 526.48 Feet to the point of a 2,884.79 Foot radius curve right; Thence along the arc of said curve right through a central angle of $04^{\circ}45^{\circ}$, 239.16 Feet (chord bears North 21°52'30" West, 239.09 Feet); Thence North 19°30' West, 154.07 Feet to the point of a 1,412.39 Foot radius curve left; Thence along the arc of said curve left through a central angle of 21°34'41". 531.92 Feet (chord bears North 30°17'20" West, 528.78 Feet) to the North line of said Section 33; Thence South 89°29'54" West along said North line, 651.24 Feet to the Point of Beginning.
