RESOLUTION NO. 255

RESOLUTION REQUESTING THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, OREGON TO TRANSFER JURISDICTION OVER PORTIONS OF CERTAIN COUNTY ROADS LYING WITHIN THE CORPORATE LIMITS OF THE CITY OF SHERWOOD FROM WASHINGTON COUNTY TO THE CITY OF SHERWOOD

WHEREAS, the City Council of the City of Sherwood is informed, advised, and finds that it is in the best interest of the City of Sherwood and its inhabitants that a portion of certain county roads, hereafter described, to the extent that same are within the territory now embraced by the corporate boundaries of the City of Sherwood, and otherwise under the jurisdiction of the county, should be transferred to the jurisdiction of the City of Sherwood.

NOW, THEREFORE, BE IT RESOLVED:

- (a) That the Board of County Commissioners of Washington County be and it is hereby respectfully petitioned and requested to relinquish and transfer to the City of Sherwood jurisdiction over the following county roads insofar as said roads are situated within the present corporate boundaries of the City of Sherwood, to-wit:
1. The full right of way of Murdock Road from a point southerly 725' of it's intersection with Tualatin-Sherwood Road, a distance of 2075' south to the Sherwood City Limits. One-half the right-of-way from a point 2075' south of it's intersection with Tualatin-Sherwood Road to a point 2700' south to the Sherwood City Limits. (Part of County Road No. 2257.)
  2. The full right-of-way of S.W. Sunset Blvd. from it's intersection with South Sherwood Blvd. westerly a Distance of 660 feet. (Part of County Road No. 441). One-half the right-of-way of S.W. Sunset Blvd. from a point 660 feet westerly of it's intersection with South Sherwood Blvd. to a point 1295.72 feet westerly of it's intersection with South Sherwood Blvd. (Part of County Road No. 441).
- (b) That the Board of County Commissioners of Washington County be respectfully requested and petitioned to undertake a proceeding in accordance with ORS 373.270, and that upon completion of proceedings make and enter an order transferring the jurisdiction of the above-referred to county roads to the City of Sherwood.
- (c) That the City Recorder be and is hereby instructed to deliver a certified copy of the foregoing resolution to the Board of County Commissioners of Washington County, Oregon.

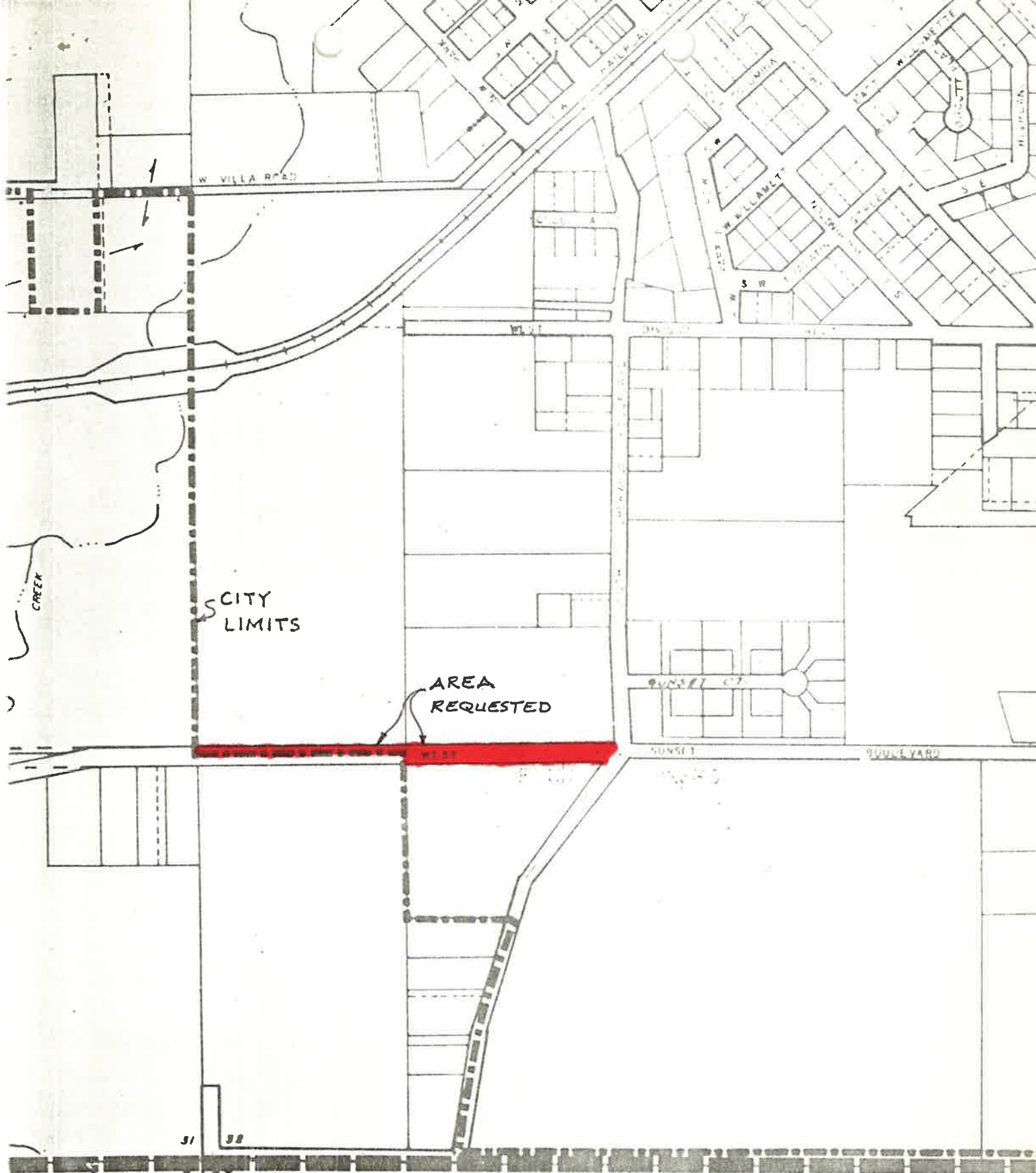

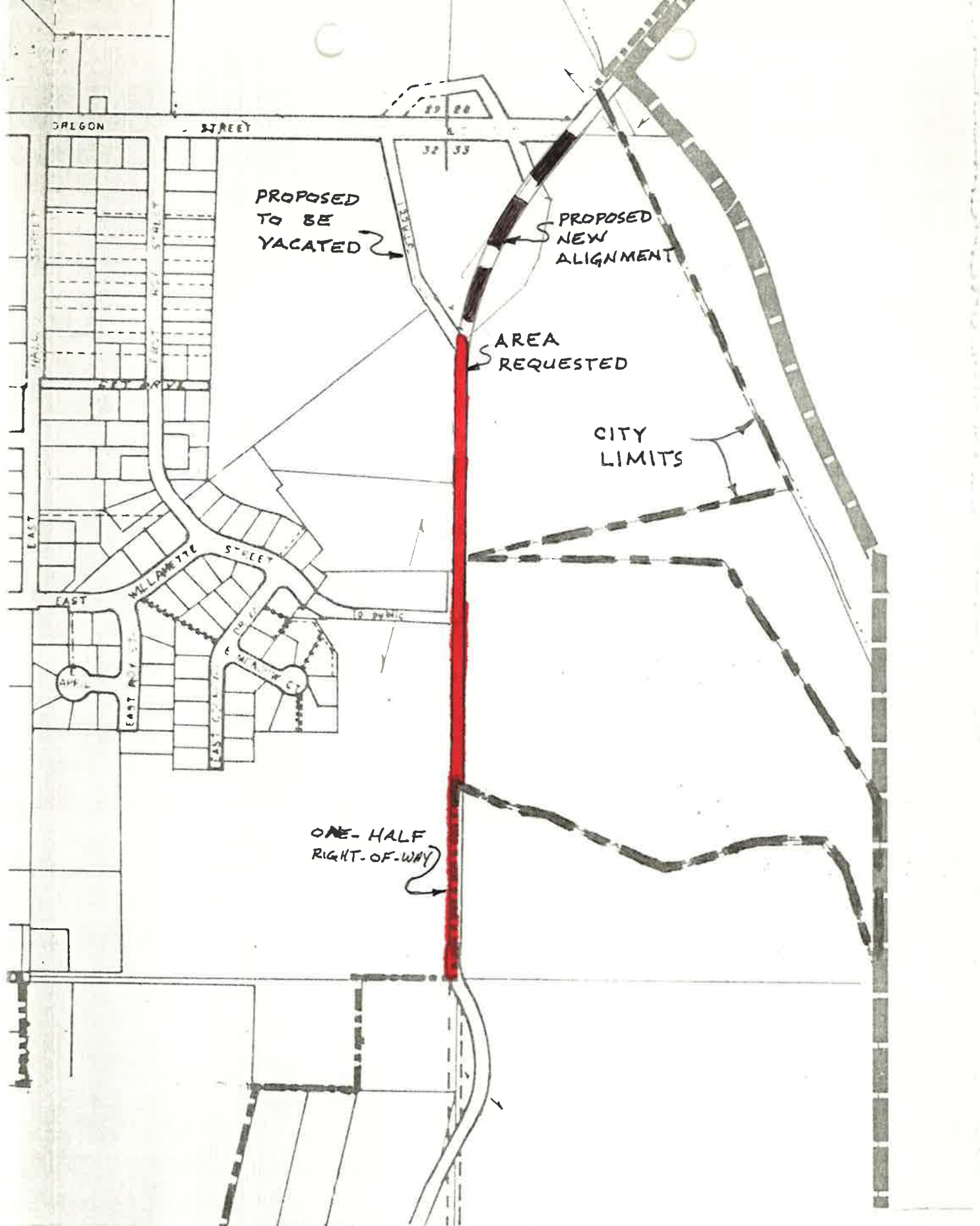
