### RESOLUTION NO. 316

A RESOLUTION AUTHORIZING AND APPROVING CONTRIBUTION AND REFUND AGREEMENTS WITH THE ST. PAUL LUTHERAN CHURCH OF SHERWOOD FOR CONSTRUCTION OF THE S.W. SCHOLLS-SHERWOOD ROAD WATERLINE.

WHEREAS, it is the policy of the City of Sherwood to participate in the cost of the replacement of existing, but inadequate, water mains on a pro rata basis.

WHEREAS, it is the policy of the City of Sherwood to ensure to the limits of its authority that property owners are compensated for any oversizing or frontending of the costs of constructing water mains.

WHEREAS, St. Paul's Lutheran Church of Sherwood is proceeding to construct a ten inch (10") water main from Edy Road to Scholls-Sherwood Road and said water main will both replace an existing waterline and potentially serve properties north and east of the Church.

NOW THEREFORE BE IT RESOLVED BY THE CITY OF SHERWOOD:

1. <u>Contribution</u>: The City agrees to pay to the Church an amount equal to \$4.00 per lineal foot of the ten inch (10") and eight inch (8") portions of the water main for its entire length from the connection to the S.W. Edy Road waterline to its easterly terminus on S.W. Scholls-Sherwood Road, as more particularly described in the attached "Contribution Agreements".

2. <u>Refund</u>: The City agrees to require of properties north and east of the Church, prior to providing water service to those properties, to refund to the Church, on a pro rata basis, an amount equal to \$4.40 per lineal foot of both the eight inch (8") and ten inch (10") portions of the watermain from the connection point at S.W. Edy Road to the terminus at S.W. Scholls-Sherwood Road, apportioned on an acre basis over all properties benefited by the oversizing, including the Church, as more particularly described in the attached "Refund Agreement".

3. <u>Authorization</u>: The City Manager is hereby authorized to execute the aforementioned Contribution and Refund Agreements on the City's behalf.

THIS AGREEMENT, made and entered into this \_\_\_\_\_ day of March, 1985, by and between the CITY OF SHERWOOD, OREGON, a municipality in the State of Oregon, hereafter designated "City", and ST. PAUL LUTHERAN CHURCH, of Sherwood, Washington County, Oregon, an Oregon Corporation, hereinafter designated "Developer".

WITNESSETH:

WHEREAS, on the \_\_\_\_\_ day of March, 1985, Developer completed the construction of the extension of a water main described as follows:

> Beginning at a point at the northern terminum of the (10") waterline serving St. Paul Lutheran Church; proceeding east 510 feet within the Southwest Scholls-Sherwood Road right-of-way to a point.

Said water line is adjacent to property other than property owned by the Developer so that water service for domestic, commercial or industrial use is provided for the following properties without further extension of the water line:

> TAX LOTS 1400, 1300 and 500 of the NE 1/4 of Section 30, T2S, RlW, of the Willamette Meridian, Washington County, Oregon.

WHEREAS, it is the policy of the CITY OF SHERWOOD to participate in the cost of the replacement of existing, but inadequate, water mains on a pro rata basis, NOW, THEREFORE, the City hereby agrees to refund to Developer an amount equal to \$4.00 per lineal foot of the water line for its entire length from the connection to the ten inch (10") water line serving St. Paul Lutheran Church to its easterly terminus on Southwest Scholls-Sherwood Road.

Payment by the City shall be made upon approval of the line constructed by Developer and acceptance of same as a public water line by the City of Sherwood.

#### REFUND AGREEMENT

THIS AGREEMENT, made and entered into this \_\_\_\_\_ day of February, 1985, by and between the CITY OF SHERWOOD, OREGON, a municipality in the State of Oregon, hereinafter designated "City", and ST. PAUL LUTHERAN CHURCH OF SHERWOOD, Washington County, Oregon, an Oregon corporation, hereinafter designated "Developer".

### WITNESSETH:

WHEREAS, on the \_\_\_\_\_ day of \_\_\_\_\_\_, 1985, Developer completed the construction of the extension of a water main described as follows:

From a connection point with the Edy Road water line, north and west to a terminus at Southwest Scholls Sherwood Road and all within the three water line easements more particularly described in Exhibits "A", "B" and "C" attached hereto and by this reference fully incorporated herein.

Said water line is adjacent to property other than property owned by the Developer so that water service for domestic, commercial or industrial use is provided for abutting properties without further extension of the water line, and has been oversized to enable future extension and adequate service to properties lying north, east and west of the terminus of the line installed by Developer. Said other properties are outlined within the red boundary shown on Exhibit "D" attached hereto and by this reference incorporated herein.

NOW, THEREFORE, City hereby agrees to require the owners of the hereinabove described properties, prior to providing water service to those properties to refund to Developer a pro rata portion of the cost of said extension. The amount to be refunded shall be based upon \$4.40 per lineal foot of the water line from the connection point at S.W. Edy Road to the terminus at Southwest Scholls Sherwood Road, apportioned on an acre basis over all properties benefited by the oversizing, including Developer's property.

City agrees to make all reasonable effort to collect for such connections the amounts as hereinafter set forth and shall pay such amounts directly to Developer. No permanent connection shall be made until payment is received unless agreed to by Developer or unless ordered to connect by a court order. In the event suit or action is filed against City that challenges the right of City to make or collect the refund charges or challenges the reasonableness thereof, Developer agrees to assume the defense of this litigation and to hold City harmless from any loss, costs, attorneys' fees and expenses dresulting therefrom. Developer agrees to be bound by any court decision on this matter.

Developer agrees that if Developer, by agreement with any of the property owners benefited by the oversized improvements to be installed by Developer, extends service to those properties from the terminus of the 10" line at Southwest Scholls Sherwood Road, Developer will do that at a cost to be paid by the property owners of the property served thereby directly to Developer. Developer will pay whatever sums are agreed upon between Developer and said extending property owners and City will not be obligated to collect for developer the cost of said extensions or for the oversizing refund called for by this agreement due from the properties served by those extensions installed by Developer beyond the 10" line terminus.

Any such extensions shall be constructed to City specifications and shall require coverage on a one year maintenance bond in a form acceptable to the City.

This agreement shall terminate at such time as Developer has received the cost of the portion of said water line eligible for refund or on the 1st day of March, 1995 (a date not to exceed ten years from date City accepts water line installation as a City line), whichever event first occurs.


