I. **BACKGROUND**

A. **Public Involvement**

The following work sessions, presentations, and public hearings for a new Water System Master Plan were advertised and held as described below. Individual electronic notice was sent to affected agencies on September 7, 2005.

As noted above, two separate presentations were provided to the Planning Commission and City Council. Murray Smith & Associates (MSA) presented a draft of the Water System Master Plan and the City of Wilsonville presented an overview of construction and operations of the Wilsonville Treatment Plant. On June 14, 2005 the Planning Commission adopted Resolution 2005-001 (Exhibit C) endorsing the Wilsonville Treatment Plant option.

On October 4, 2005 the City Council will hold a public hearing on Resolution 2005-057 (Exhibit D) to accept the Water System Master Plan. This action will authorize staff to initiate the plan amendment process to update the public facility in this update. The new map was evaluated using the existing inventory from 1999 as a measurement, does not propose new policies, other than a new water supply, and the implementation strategies are consistent with regional and state policy. The proposal does not include any new zoning designations. Based on the above analysis and findings, the standard is met.

B. There is an existing and demonstrable need for the particular uses and zoning proposed, taking into account the importance of such uses to the economy of the City, the existing market demand for any goods or services which such uses will provide, the presence or absence and location of other such uses or similar uses in the area, and the general public good.

Finding: The proposed plan map does not propose changes in use or zones. The proposed Comprehensive Plan Map amendment updates inventories and plans future water facilities to better serve residents and businesses. It also clarifies policy goals and objectives for the future supply and distribution of water. This standard does not apply.

C. The proposed amendment is timely, considering the pattern of development in the area, surrounding land uses, any changes which may have occurred in the neighborhood or community to warrant the proposed amendment, and the availability of utilities and services to serve all potential uses in the proposed zoning district.

Finding: Clearly, the proposed plan map is timely given the last update was completed in 1999 and the population increased by 2,500 new residents over the last five years¹. The proposal outlines the need for new water facilities and plans for improvements over a twenty year period to meet anticipated demand and serve businesses and residents more effectively and efficiently given available funding and resources. This standard is met.

D. Other lands in the City already zoned for the proposed uses are either unavailable or unsuitable for immediate development due to location, size or other factors.

Finding: The request does not change the underlying zones. This criterion does not apply.

III. RECOMMENDATION

Based on the above findings of fact, staff recommends approval of the plan map amendment (PA 05-01) subject to the following conditions:

- 1. Replace existing references to the existing 1990 Water Service Plan Update (Resolution 88-407) that were incorporated into the Sherwood Community Plan, Part 2, Chapter 7 (Ordinance 91-922) with the new plan map ("Plate 1") and develop an implementing ordinance codifying the provisions for a City Council hearing and review.
- 2. Replace all existing water plan maps with new maps contained in the Water System Master Plan and clearly mark with new adoption dates.
- 3. Upon Council approval send a "Notice of Adoption" to DLCD within five calendar days and a Notice of Decision to interested parties who requested such.
- 4. Direct staff to replace existing copies of 1999 Water System Master Plan with new versions, upload an electronic version to the city website subject to addressing security concerns, and provide a new copy to the Sherwood Library for reference.
- 5. After a new Economic Development Element is adopted, evaluate the Water System Master Plan and propose amendments to facilitate economic development conditions to site target industries.

The City received a land use application for Site Plan approval for a used car lot at 21655 SW Pacific Highway on August 1, 2005. The application has not yet been deemed complete.

While a car sales lot is listed as a permitted use in the Section 2.110.02 (General Commercial, page 38), Section 5.504 (page 22) of the Code states that outdoor sales is only permitted when such activity is deemed by the Commission to be a "customary and integral part of a permitted commercial or industrial use." It also states that outdoor sales and merchandise display will be reviewed as a conditional use in accordance with Section 4.300.

Both Site Plans between 15,001 and 40,000 square feet and Conditional Uses are reviewed by the Hearings Officer. However, since the code specifically states that the Commission shall determine that the outdoor sales use is a customary and integral part of the permitted use, we are asking the Planning Commission to formally acknowledge that outdoor display of vehicles is a customary and integral part of a car sales lot. The Hearings Officer will review all other aspects for compliance with both the Site Plan standards and the Conditional Use standards.

Action requested: Provide confirmation that the Planning Commission determines outdoor display of vehicles to be a customary and integral part of a car sales lot, which is a permitted use in the GC zone.
