City of Sherwood, Oregon Planning Commission Minutes September 2, 2003

1. Call to Order/Roll Call

Chair Adrian Emery called the Planning Commission meeting to order at 7:00 PM.

2. Consent Agenda

Chair Emery asked if there were any additions or corrections to the August 19, 2003 Regular Commission meeting minutes. The Commission changed the words "stand alone" in paragraph 3, page 6, to "destination". The Commission also added the word "commercial" to the paragraph under New Business, page 7, "...was clear that mini-warehousing and commercial storage is not an allowed use in the LI zone."

Patrick Allen moved the Planning Commission accept the August 19, 2003 Planning Commission meeting minutes as amended. Seconded by Kevin Henry.

5. Sherwood TSP – Future Needs (DKS Associates)

Carl Springer, DKS Associates, reviewed the Transportation System Plan (TSP) project schedule and major milestones. He presented an overview of the TSP Draft Chapter 4, specifically pedestrian, bicycle, transit, motor vehicle needs and other modes. He introduced possible changes to the Transportation Goals & Policies that included an overview of how existing comprehensive plan elements may be reorganized (draft document included for Commission review).

The Commission made the following comments:

- Mr. Allen was concerned about the bike paths on streets.
- Mr. Emery commented on the transit service, stating that the park 'n ride needs to be located out of Old Town.
- Ms. Lafayette asked for clarification regarding week-end traffic counts versus peak hour traffic. Mr. Springer responded that the data in ITE specific to week-end traffic is weak.

Mr. Springer noted the next steps will be to start on the program alternatives, where the response to the existing conditions will take shape in specific evaluation and recommendations to fix current problems with Sherwood's transportation system.

There being no further business to discuss, Chair Emery adjourned the regular Commission meeting at 8:45 PM.
