## Planning Commission Minutes June 16, 1998

### 1. Call to Order/Roll Call

Vice-Chair Susan Claus called the meeting to order at 7:00 PM.

### 2. Minutes of May 14, 1998, May 19, 1998, June 2, 1998

Vice-Chair Claus asked if there were any corrections, additions or deletions to the minutes of May 5, 1998. There were none.

Adrian Emery moved the Planning Commission accept the May 14, 1998, May 19, 1998 and June 2, 1998 Planning Commission minutes as presented. Seconded by Keith Mays.

### 3. Agenda Review

### 5. Public Hearings

Vice-Chair Claus announced she would not be participating in Agenda Items 5A MLP 98-2 Claus Partition (Columbia Street) or 5B SUB 98-4/VAR 98-1 Wildlife Haven Preliminary Plat. She turned the meeting over to Acting Chair Angela Weeks.

### **5A. MLP 98-2 Claus Partition (Columbia Street)** (continued from May 19, 1998)

Acting Chair Weeks asked if the Commission wished to re-open the public hearing for further testimony or to receive additional information. The applicant, Robert J. Claus, announced he would like this agenda item continued.

Adrian Emery moved the Planning Commission continue MLP 98-2 Claus Partition (Columbia Street) to the July 7, 1998 Regular Commission meeting as requested by the applicant. Seconded by Keith Mays.

### 5B. SUB 98-4/VAR 98-1 Wildlife Haven Preliminary Plat

Acting Chair Weeks announced that Staff was recommending this application be continued to the July 7, 1998 Regular Commission meeting.

Keith Mays moved the Planning Commission continue SUB 98-4/VAR 98-1 Wildlife Haven Preliminary Plat to the July 7, 1998 Regular Commission meeting as requested by Staff. Seconded by Adrian Emery.

### **6.** Community Comments

Vice-Chair Claus resumed the Chair position. Vice-Chair Claus asked if there was anyone who wished to speak on any items not included on the Agenda. There were no comments.

### 7. Other Business

Staff advised the Commission that a copy of the Water Service Agreement with George Andrews had been included in the packets for their information.

Staff referred the Commission to excerpts from the May 6, 1997 and May 20, 1997 Planning Commission meeting minutes regarding the pedestrian bridge on West Villa Road.

Sue Engels advised Staff is recommending holding a workshop meeting for the Planning Commission on June 30, 1998. The purpose of the meeting would be for the Commission to review the preliminary Transportation System Plan (TSP). The attending Commission members agreed to this date and asked that the other Commission members be advised. Vice-Chair Claus asked if this workshop could be a joint session with the City Council. With regard to the length of the meeting. Ms. Engels said it would probably be within a 2 hour time frame.

Jason Tuck reviewed the upcoming land use application schedule. He introduced Ted Knowlton, the Planning Department Intern, who was in attendance.

Greg Turner advised that the City Council had not yet heard the plan text amendment for streamlining the planning process. At this time, this amendment is scheduled for the June 23, 1998 City Council meeting. He would confirm whether Council will hold a work session prior to holding the public hearing on this proposed amendment.

Vice-Chair Claus asked if the contract for South Sherwood Boulevard improvements had been let. Staff will check on the status of this project.

There being no further business to discuss, the Commission meeting was adjourned at 7:20 PM.
