**A RESOLUTION AWARDING THE BID FOR GLENEAGLE STREET LIGHT
PROJECT**

WHEREAS, on December 2, 1996, the City Manager authorized staff to prepare bid documents and call for bids for Gleneagle Street Lights project; and

WHEREAS, the project was advertised in the Daily Journal of Commerce on December 16, 1996; and

WHEREAS, two bids were received prior to the close of the bid period on December 27, 1996; and

WHEREAS, Frahler Electric Company of Tigard, Oregon submitted the low bid for the project in the amount of \$34,492.00, which consists of all labor, materials, and equipment necessary to complete the work described in the Base Bid; and

WHEREAS, work on the project will occur between February 3, 1997 and March 3, 1997.

NOW, THEREFORE, THE CITY RESOLVES AS FOLLOWS:

Section 1: The contract is awarded to Frahler Electric Company of Tigard, Oregon.


